SUMMARY

Public Works Agency requests Council approval of a resolution authorizing the City Administrator to utilize funding supplied by the Oakland Redevelopment Agency to increase funding for the San Pablo Pedestrian Streetlights Project by up to \$350,000.00 for a total project budget of \$1,850,000.00. Public Works Agency also requests Council approval to increase the value of the current contract with Ray's Electric up to \$218,000.00 for a total value of \$835,000.00. These increases will allow for additional lighting, sidewalk repair, and ADA compliant ramps along San Pablo Avenue, from the Emeryville border to the Berkeley border, needed to complete the San Pablo Pedestrian Streetlights Project.

FISCAL IMPACT

A total of up to \$350,000.00 requested to complete this project will be provided--under the Cooperation Agreement between the Agency and the City--from the Broadway/MacArthur/San Pablo Tax Allocation Bonds, Series 2006C-TE Fund (9537), Miscellaneous Infrastructure - ORA Project (T314910). The funds will be accepted and appropriated to the Redevelopment Agency Projects Fund (7780), San Pablo Lights Project - City (C315010).

BACKGROUND

City Council Resolution No. 81953 C.M.S. dated July 5, 2009, authorized the contract award of \$617,000.00 to Ray's Electric as the sole contractor for the San Pablo Pedestrian Streetlights Project. The project includes the installation of 60 ornamental pedestrian streetlights, the replacement of 60 trolley pole streetlights, the removal of overhead streetlight wires, and the installation of new underground wiring on San Pablo Avenue between the Emeryville Border (53rd Street) and the Berkeley Border (67th Street). This project involves joint work by an outside contractor and City staff. Once the Contractor completes the substructure, staff will install new streetlights and wiring, whereupon the Contractor will finish the project with the removal of existing facilities and trolley poles.

A change to the original design is required to upgrade the sidewalk curb ramps to meet current ADA codes. In conjunction with this upgrade, various sidewalk areas will be repaired or replaced to minimize tripping hazards; additionally, extra pedestrian lights will be added.

The original project budget is insufficient for the implementation of these required changes and therefore an increase to the overall budget is requested. Staff seeks to increase the contract value for Ray's Electric to incorporate the additional ADA and lighting work. The total cost increase to the project is \$350,000.00, which accounts for the additional contractor cost of up to \$218,000.00 for sub-structure work and additional City staff costs of \$132,000.00 for materials, fixture installation, inspection and project administration.

KEY ISSUES AND IMPACTS

Funding for San Pablo Pedestrian Streetlights Project was approved and adopted in the FY 07-09 Redevelopment Agency and City Policy Budget. Funds available for the original approved award, as well as for this request for additional appropriation for this project were budgeted as follows:

The additional funds totaling \$350,000 will be appropriated as shown in "Exhibit A: Details of Project Funding" and is summarized as follows:

Increase Ray's Electric Contract: \$218,000.00
Increase for City Material and Labor: \$132,000.00
Total: \$350,000.00

PROJECT DESCRIPTION

The San Pablo Pedestrian Streetlights Project will improve the street and sidewalk lighting on San Pablo Avenue, which is a main arterial roadway and commercial corridor. It will benefit the residents, property owners, merchants, and the community by enhancing the lighting at the sidewalk level for improved visibility. The overhead streetlight wires will be removed and replaced with new underground wiring, and the trolley poles will be replaced with cobra head streetlights and poles. The project is expected to be completed by the end of April 2010. See Project Schedule – *Attachment A*.

EVALUATION OF PAST PERFORMANCE

The City has evaluated Ray's Electric, Inc., performance on a previous City project completed in 2008. Ray's Electric performance was rated "average" in that evaluation.

SUSTAINABLE OPPORTUNITIES

Economic: The contractor is a small local company, indigenous to the City. The pedestrian streetlights project supports local businesses, property owners, and the community in general by providing aesthetic upgrades to the sidewalk and curb ramps and will enhance the lighting level for pedestrians patronizing the area in the evening.

Environmental: The project will enhance the general environment with the removal of lead based painted trolley poles and the removal of overhead streetlight wiring. The removal of the trolley poles will enhance the area's aesthetics for the community.

Social Equity: The installation of ADA compliant ramps and the repair of uneven sidewalk concrete will ensure equal access to all pedestrian traffic. The new pedestrian streetlights will enhance the safety and security of the sidewalks.

DISABILITY AND SENIOR CITIZEN ACCESS

Improved pedestrian lighting, along with the removal of trolley poles and the repair of uneven sidewalk, will enhance the right of way. The addition of ADA compliant ramps will facilitate access by seniors and persons with disabilities utilizing the corridor.



AN AGENCY RESOLUTION ALLOCATING UP TO AN ADDITIONAL \$350,000 FROM THE BROADWAY/MACARTHUR/SAN PABLO TAX ALLOCATION BOND SERIES 2006C-TE TO THE CITY OF OAKLAND UNDER THE COOPERATION AGREEMENT FOR THE SAN PABLO GOLDEN GATE DISTRICT PEDESTRAN STREETLIGHTS PROJECT, INCREASING THE TOTAL PROJECT BUDGET FROM \$1,500,000 TO \$1,850,000

WHEREAS, the Broadway/MacArthur/San Pablo Redevelopment Project Area Committee (PAC) has prioritized improving the lighting in the San Pablo Avenue Golden Gate District since the adoption of the Redevelopment Plan; and

WHEREAS, the Broadway/MacArthur/San Pablo Redevelopment Area was issued its first bond on October 12, 2006 and Broadway/MacArthur/San Pablo Tax Allocation Bonds Series 2006C-TE proceeds are available for capital improvement projects in the Project Area; and

WHEREAS, the San Pablo Golden Gate Pedestrian Streetlights Project is located on San Pablo Avenue between 53rd and 67th Streets within the boundaries of the Broadway/MacArthur/San Pablo Redevelopment Project Area and includes the installation of new ornamental pedestrian street lights along San Pablo Avenue between 53rd and 67th Streets; and

WHEREAS, the Five Year Implementation Plan for the Broadway/ MacArthur/ San Pablo Redevelopment Project, adopted on December 7, 2004 (Resolution No. 2004-66 C.M.S.), includes infrastructure upgrades including lighting and streetscape improvements within the Project Area; and

WHEREAS, the City and the Redevelopment Agency entered into a Cooperation Agreement on July 1, 2004, which generally governs the provision of assistance and the payment of funds between the two agencies, including Agency financial contributions and other assistance to support City public improvements; and

WHEREAS, Section 33445 of the California Health and Safety Code authorizes a redevelopment agency to pay for the cost of installation or construction of publicly-owned facilities, if the legislative body has consented to such funding and has made certain findings; and

WHEREAS, a total of \$1,500,000 of Redevelopment Agency funds for this project was included in the Fiscal Year 2007-08 Proposed Agency Budget from Broadway/MacArthur/San Pablo Tax Allocation Bonds, Series 2006C-TE Fund (9537), Redevelopment Projects Organization (88669), San Pablo Lights - ORA (T314910); and

WHEREAS, the budget for this project has increased by \$350,000 to a total project budget of \$1,850,000; and

WHEREAS, the City Council is consenting to the use of Agency funds for the implementation of the San Pablo Golden Gate Pedestrian Streetlights Project; now therefore be it

RESOLVED: That the Redevelopment Agency hereby authorizes the allocation of up to an additional \$350,000 of Redevelopment Agency Broadway/MacArthur/San Pablo Project Area funds from the Broadway/MacArthur/San Pablo Tax Allocation Bonds, Series 2006C-TE Fund (9537), Miscellaneous Infrastructure - ORA (T314810) to the San Pablo Lights - ORA (T314910) and the City of Oakland Repayment Fund (7780), San Pablo Lights Project - City (C315010) mirror project under the Cooperation Agreement between the City and the Redevelopment Agency to fund the San Pablo Golden Gate Pedestrian Streetlights Project; and be it further

AN**ADDITIONAL** RESOLUTION **ACCEPTING** \$350,000 REDEVELOPMENT CONTRIBUTION FROM THE AGENCY UNDER THE COOPERATION AGREEMENT FOR THE SAN PABLO PEDESTRIAN STREETLIGHTS PROJECT. FOR PROJECT BUDGET OF \$1,850,000, AND WAIVING THE CITY'S COMPETITIVE BIDDING REQUIREMENT AND INCREASING THE CONTRACT WITH RAY'S ELECTRIC IN THE AMOUNT OF \$218,000, FOR A TOTAL CONTRACT AMOUNT OF \$835,000 FOR THE PROJECT

WHEREAS, the San Pablo Pedestrian Streetlights Project in Oakland, is located on State Highway 123, between the Emeryville border and the Berkeley border, and pursuant to a competitive bid, Council Resolution No. 81953 C.M.S. had awarded a contract of \$617,502 to Ray's Electric, to construct the substructure, with City staff procuring the materials and doing the wiring; and

WHEREAS, the City wishes to add ADA ramps, restore uneven sidewalk and further add pedestrian streetlights in the project area, and it is necessary for the Council to (1) waive the City's competitive bidding requirement set forth in Section 2.04.040 B 2 and Section 2.04.050 of the Oakland Municipal Code (the "OMC") because it is in the best interest of the City to do so pursuant to Oakland Municipal Code Section 2.04.0 50 I, 5, and (2) authorize an increase of the contract with Ray's Electric by up to \$218,000 for the additional project work; and

WHEREAS, Section 33445 of the California Health and Safety Code authorizes a redevelopment agency to pay for the cost of installation or construction of publicly-owned facilities, if the legislative body has consented to such funding and has made certain findings; and

WHEREAS, a total of \$1,500,000 of Redevelopment Agency funds for this project was included in the Fiscal Year 2007-08 Proposed Agency Budget from Broadway/MacArthur/San Pablo Tax Allocation Bonds, Series 2006C-TE Fund (9537), Redevelopment Projects Organization (88669), San Pablo Lights - ORA (T314910); and

WHEREAS, the budget for this project has increased by \$350,000 to a total project budget of \$1,850,000; and

WHEREAS, the Redevelopment Agency has approved an additional \$350,000 contribution to the San Pablo Pedestrian Streetlights Project; and

WHEREAS, the City lacks the equipment and qualified personnel to perform the necessary work; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; and

WHEREAS, the City Council finds that the City staff is installing and wiring the streetlights in the project, and there will be an increase in the scope of work for City staff, the budget for staff will also need to be increased to cover the additional material and labor needed; and

WHEREAS, the City Council finds that the increase in the scope of work for contractor and the City staff, Council hereby appropriate additional funds for this expanded scope of work by the amounts shown in Exhibit A: Details of Project Funding; now, therefore, be it

RESOLVED: That the City hereby accepts additional Agency funds in an amount not to exceed \$350,000 under the Cooperation Agreement for the San Pablo Pedestrian Streetlights Project, and appropriates such funds to the Oakland Redevelopment Agency Fund (7780), San Pablo Pedestrian Streetlights Project (C315010); and be it

FURTHER RESOLVED: That the City Council hereby finds and determines as follows:

- 1. That the funding of the San Pablo Pedestrian Streetlights Project will benefit the Broadway/MacArthur/San Pablo Project Area by improving pedestrian safety along San Pablo Avenue between 53rd and 67th Streets;
- 2. That due to fiscal constraints on the City's general fund and the high number of capital projects competing for limited City funds, the City's Capital Improvement Program is unable to provide financing for this work, and therefore no other reasonable means of financing the San Pablo Pedestrian Streetlights Project are available to the City other than Redevelopment Agency funding; and
- 3. That the use of redevelopment funds from the Broadway/MacArthur/San Pablo Project Area for the San Pablo Pedestrian Streetlights Project will assist in the elimination of blight through streetscape improvements along San Pablo Avenue in the Broadway/MacArthur/San Pablo Project Area and is consistent with the implementation plan adopted for the Broadway/MacArthur/San Pablo Project Area; and be it

FURTHER RESOLVED: That the Council hereby finds and determines that pursuant to OMC 2.04.050 I 5, it is in the best interests of the City to waive the City's competitive bidding requirements set forth in OMC Section 2.04.040 B 2 and OMC Section 2.04.050, because Ray's Electric has already been awarded the original contract which was formally and competitively bid out, and it would be disruptive and cause unnecessarily delay to the project to have to formally and competitively bid out the additional contract work for the project and to possibly have to switch project contractors in the middle of project construction; and be it

FURTHER RESOLVED: That the Council hereby authorize the City Administrator to increase the contract with Ray's Electric by up to \$218,000 for a total contract amount of up to \$835,000 for needed work to complete the implementation of street lighting in connection with the San Pablo Pedestrian Streetlights Project, and be it

FURTHER RESOLVED: That the Council hereby authorizes the City Administrator to increase funding for City staff, by up to \$132,000, to cover for additional materials and labor; and be it

FURTHER RESOLVED: That the Council hereby authorizes the City Administrator to appropriate the additional funds of \$132,000 for staff to expend on materials and labor as per Exhibit A: Details of Project Funding; and be it

FURTHER RESOLVED: The contractor will be required to meet all the City's local business and employment program requirements; and be it

FURTHER RESOLVED: That the contractor shall provide a faithful performance bond and payment bond to guarantee payment of all claims for labor and materials furnished and for the amount due under the Unemployment Insurance Act, for one hundred percent (100%) of the contract amount prior to execution of the contract; and be it

FURTHER RESOLVED: That the City Council hereby approves the plans and specifications for the revised Project (C315010); and be it

FURTHER RESOLVED: That the City Administrator, or the City Administrator's designee, is hereby authorized to approve any subsequent amendments, modifications, change orders or extensions of said agreement, provided that such amendments, modifications, change orders or extensions shall be approved as to form and legality by the City Attorney's Office and filed with the Office of the City Clerk.
