

**RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO USE HER DISCRETION IN IDENTIFYING FUNDS IN THE AMOUNT OF FIFTY-SIX THOUSAND DOLLARS (\$56,000), WITH THE EXCEPTION OF THE USE OF POLICE SALARY SAVINGS, TO FUND THE OAKLAND POLICE DEPARTMENT'S 2007-2008 SCHOOL YEAR INTERNSHIP PROGRAM**

**WHEREAS**, the Department will hire 10 student interns at a pay rate of \$10.00 per hour, four hours a day, five days a week, at a total cost of \$56,000 for the year, and

**WHEREAS**, the Department sought funding for the School Year Internship program during budget deliberations for FY 07-08, but did not receive funding; and

**WHEREAS**, the OPD School Year Internship Program will assist OPD in its recruiting efforts by providing an opportunity for staff to develop and mentor students who have law enforcement as a career interest; and

**WHEREAS**, the Finance and Management Committee authorized the City Administrator to use her discretion in funding the Internship Program without using Police Department Salary Savings; now, therefore be it

**RESOLVED**: That the City Council does hereby authorize the City Administrator to exercise her discretion in identifying fifty six thousand dollars (\$56,000.00), with the exception of Police Salary Savings, to administer the Police Department's 2007-2008 School Year Internship Program beginning October 2007; and be it

**FURTHER RESOLVED**: That in the event funds requiring an appropriation or re-appropriation action by the City Council are to be used for Oakland Police Intern Program, the City Administrator shall return to Council with an appropriation resolution.
