- Initiated and secured the Legislature's and the Administration's approval for a new Restitution Tracking System to monitor compliance with statutes requiring the imposition of restitution fines and orders on a court-by-court; upon its approval, contracted with a software consultant to design and implement this system statewide.
- Established a revolving fund checking account piloted in four counties to allow the expeditious payment of funeral/burial expenses up to \$5,000 per claim; such expenses cannot be paid by the victim/claimant on a deferred billing basis, as would be the case with medical or counseling expenses; based upon the successful pilot program this program will be expanded to included all counties statewide.
