RE: **A Status Report on the Excess Litter Fee Program**

SUMMARY

The Excess Litter Fee was established and implemented in 2006 to raise revenue to abate litter created by fast food businesses, liquor stores, convenience markets and gasoline station markets. These types of establishments pay an Excess Litter Fee based on the size of their business. Revenue generated from the fee is used to defray the cost of litter and trash clean-up resulting from the operation of these businesses.

A Request for Proposals for continued implementation of the Excess Litter Fee Program was issued on July 22, 2008. The contract was awarded to Civicorps Schools and on January 5, 2009 the City entered into a two year professional services agreement, with two one-year options for renewal, with Civicorps Schools for implementation of the Excess Litter Fee Program in an amount not to exceed \$400,000 each year.

FISCAL IMPACT

During FY 2007-08, the Excess Litter Fee generated **\$363,833** in revenue with expenditures of **\$241,214**. For FY 2008-09, revenues to date total **\$401,674** with expenditures of **\$391,212**. Revenues are deposited and expenses charged to the Excess Litter Fee Fund (2417).

BACKGROUND

The City Council adopted the "Excess Litter Fee" ordinance (Ordinance No. 12727 C.M.S.) on February 21, 2006 with the goal of creating and maintaining clean city sidewalks, streets and public spaces. On June 20, 2006, the City Council adopted amendments to the Master Fee Schedule, effective July 1, 2006, to add a series of fees associated with the removal of excess litter in the areas around fast food businesses, liquor stores, convenience markets and gasoline station markets.

The City Council, adopted Resolution No. 81702 C.M.S. authorizing the execution of a two year professional services agreement, with two one-year options for renewal, with Civicorps Schools for continued implementation of the Excess Litter Fee Program.

KEY ISSUES AND IMPACTS

To help maintain and keep the City of Oakland clean by having fast food restaurants, liquor stores, convenience markets and gasoline station markets pay an Excess Litter Fee in order to assist with trash and litter generated by their businesses. The fee is based on an establishment's annual gross receipts as follows:

| • Small Business (annual gross receipts between \$5,000 and \$500,000) | \$ 230 |
| • Medium Business (annual gross receipts between \$500,001 and \$1,000,000) | \$ 910 |

There are currently 565 businesses which are assessed the Excess Litter Fee (382 small businesses, 78 medium businesses and 105 large businesses). The Excess Litter Fee has generated \$401,674 in revenue this fiscal year.

PROGRAM DESCRIPTION

During the first 6 months of the service contract with Civicorps (January 2009 through June 2009), a total of **3906** bags of litter were collected. A chart of the litter collections by Council District is provided below and *Attachment A* includes a daily breakdown of litter collections by month and Council district.

Excess Litter Fee Program Approach

Pursuant to their contract with the City, Civicorps provides litter collection in pre-designated areas for the City's Excess Litter Fee Program. The areas targeted for litter reduction by the City's contract with Civicorps are included as *Attachment B*. Civicorps is responsible for leading the day-to-day work. This includes, but is not limited to, full program development and implementation in consultation with the Office of the City Administrator. In addition Civicorps is responsible for staff recruitment, intake, training, assessment, data collection, tracking and reporting, performance measures, payroll and program evaluation.

Currently Civicorps maintains 2 teams comprised of 7 crew members and a Supervisor. The teams collect litter in the designated areas twice per week. In order to more effectively pick up litter, Civicorps has divided the City into two geographic zones comprised of the designated areas for litter pickup. Area 1 contains the West and North Oakland litter pick up areas, and Area 2 is comprised of Central and East Oakland. These areas are then further subdivided into routes that are conducive to the teams covering the designated areas within the allotted days. At the end of each month Civicorps provides progress and issue reports to the City Administrator's Office.

Civicorps is required to provide the detailed activity reports to the City within 15 days of the end of each month. City staff conducts periodic field visits to ensure that the program is operating effectively. To date the program has been operating in a manner consistent with the requirements of the contract.

The contracted services include:

- Collection of litter from sidewalks, gutters, storm drains and tree wells on a year round basis. Litter is collected twice each week from targeted streets and neighborhoods near fast food businesses, liquor stores, convenience markets and gasoline station markets.^{††}
- Tracking and reporting the number of bags of litter collected from each location.
- Reporting illegal dumping and or coordinating with the Public Works Agency – Keep Oakland Clean and Beautiful (KOCB) campaign for the elimination of blight items not covered by their service contract.

Civicorps Background

Civicorps Schools (formerly the East Bay Conservation Corps) has been serving Oakland youth since 1983. The Civicorps program combines a conservation corps model with an educational program allowing 18-24 year olds to earn their high school diplomas while providing a service to their community. Civicorps has worked on a number of projects for the City of Oakland. Currently, Civicorps works with the Oakland Fire Department for removal of flammable green waste from residents requesting pickup. The Civicorps crew collects, chips and disposes of the flammable green waste. Civicorps' Project YES (Youth Engaged in Service) operates service-learning projects in all of the middle schools in Oakland Unified School District. Project YES students conducted graffiti abatement throughout the City. The Civicorps recycling team picks up recyclables from business throughout the City, at Oakland A's games, Raiders Games and City of Oakland events. Under a current contract with the Port of Oakland, Civicorps maintains the Oakland Embarcadero area from Jack London Square to the bridge to Coast Guard Island on Embarcadero and from Maritime to Seventh Street. This work includes removing litter and weeds, including tracking the number of garbage bags and recyclables collected. Civicorps has provided litter clean up services to the East Bay Regional Park District for over twenty years and

^{††} Litter is defined as discarding, dropping, or scattering of small quantities of waste matter ordinarily carried on or about the person, including, but not limited to, beverage containers and closures, packaging, wrappers, wastepaper, newspapers, and magazines, in a place other than a place or container for the proper disposal thereof, and including waste matter which escapes or is allowed to escape from a container, receptacle, or package.

currently has a two year litter abatement contract with Caltrans to pick up litter and remove weeds.


Excess Litter Fee Brochure



ATTACHMENT C

ELIGIBLE BUSINESSES DEFINED: (ORD 12727)

CONVENIENCE MARKET: means any business engaged in the retail sale of food, beverages and small personal convenience items, primarily for immediate off-premises consumption and typically found in establishments with long or late hours of operation but excludes delicatessens and other specialty food shops and businesses, businesses that are engaged in Large-Scale Combined Retail and Grocery Sales Commercial Activities as defined by Oakland Municipal code Section 17.10.345 and businesses that have a sizeable assortment of fresh fruits and vegetables and fresh-cut meat.

FAST FOOD BUSINESS: means any business engaged in the retail sale of ready-to-eat prepared foods and beverages, for on or off premises consumption; whenever the foods and beverages are available upon a short waiting time and are primarily served in or on disposable wrappers, containers, or plates. Fast Food Businesses may also exhibit other design and operating characteristics, including: (a) a limited menu; (B) food is typically ordered and served at a service counter; (C) food is paid for prior to consumption; (D) the facility in which the activity/use is occurring provides a take-out counter space and space for customer queuing. They also include certain activities accessory to the above, as specified in Section 17.10.040. In those areas of the City subject to the vehicular food vending pilot program ordinance, a business engaged in "vehicular food vending," as defined by Section 17.10.290, is not considered a Fast Food Business.

GASOLINE MARKET: means any business engaged in the retail sale of food, beverages and small personal convenience items along with the retail sale of gasoline but excludes any business engaged in Large-Scale Combined Retail and Grocery Sales Commercial Activity as defined in Oakland Municipal Code Section 17.10.345 and excludes wholesale clubs or other establishments selling primary bulk merchandise and charging membership dues or otherwise restricting merchandise sales to customers paying a periodic access fee.

LIQUOR STORE: means any business engaged in Alcoholic Beverage Sales Commercial Activity as defined in Oakland Municipal Code Section 17.10.300 but excludes any business engaged in Large-Scale Combined Retail and Grocery Sales Commercial Activity as defined in Oakland Municipal Code Section 17.10.345 and excludes wholesale clubs or other establishments selling primary bulk merchandise and charging membership dues or otherwise restricting merchandise sales to customers paying a periodic access fee.

WHAT IS THE EXCESS LITTER FEE PROGRAM?

WHAT IS THE EXCESS LITTER FEE PROGRAM?

On February 21, 2006, under Ordinance 12727, the City of Oakland established an Excess Litter Fee on Fast Food Businesses, Convenience Markets, Gasoline Station Markets, and Liquor Stores. The ordinance's purpose was to create and maintain safe, clean and sanitary streets, sidewalks, and public spaces by assessing a fee on businesses known to generate particularly high amounts of disposable materials that end up as litter on the streets. The fee has provided the resources to collect and dispose of the litter to keep our City clean and prevented litter from entering the City's storm water runoff system that can potentially pollute those waters and/or hamper the proper performance of the runoff system.



WHO IS REQUIRED TO FILE AND PAY

- Fast Food Businesses
- Convenience Markets
- Gasoline Station Markets
- Liquor Stores

Every eligible business must file an Excess Litter Fee declaration and pay an annual fee on or before September 30th of each year. The basis for the fee is your annual gross receipts—except receipts for the sale of alcohol, gasoline or automotive services or products. Your fee covers the period from October 1 through September 30th of the following year. Eligible businesses in Business Improvement Districts (BID) that currently pay BID assessments are required to pay only 50% of the litter fee. Vehicular food vendors are not subject to the fee.

HOW MUCH AM I REQUIRED TO PAY?

The fee is based on your prior calendar year's gross receipts. The following classifications apply:

- Large Business with annual gross receipts of \$1,000,000 or more pay \$3,815.00.
- Medium business with annual gross receipts between \$500,000 and \$999,999 pay \$910.00.
- Small Business with annual gross receipts between \$5,000 and \$499,999 pay \$230.00.
- Annual gross receipts between \$0 and \$4,999 pay no fee.

Note: Gross receipts do not include receipts for the sale of alcohol, gasoline or automotive services or products.

WHO IS ELIGIBLE FOR REDUCED FEES OR EXEMPTIONS?

Eligible businesses in Business Improvement Districts (i.e. Rockridge, Montclair, Fruitvale, Laurel, Lakeshore/Lake Park, Temescal/ Telegraph Ave, etc.) that are currently paying assessments to a Business Improvement District pay only 50% (fifty) percent of the fee.

The City Administrator or designee may **further exempt or reduce the fee** of any eligible business from the Excess Litter Fee if they determine that:

1. Such eligible Businesses' respective Business Improvement District is not within 3 blocks of a Targeted Street; or
2. If Eligible Businesses' respective Business Improvement District is within 3 blocks of a Targeted Street, and the Business Improvement District has an effective program to clean up litter originating from the eligible businesses on the Targeted Street.
3. The business has an effective program to reduce litter originating from the business that actually decreases the burden of corresponding litter cleanup or other cost to the City from litter originating from that business.

HOW DO I FILE AN APPEAL?

Businesses may appeal directly to a designated hearing officer by filing an appeal form. The form must be submitted by the due date stated on the City's notice and must include an appeal filing fee of \$67.50. The filing fee will be refunded to you if your appeal is upheld.

Through written declarations and other evidence submitted with the form, all appeals must demonstrate to the hearing officer one of the following conditions to reduce or exempt the business from the fee: 1) By definition of the ordinance, the business is not subject to the fee; 2) The business has been misclassified (should be small vs. medium, etc.); 3) The business is in a BID and/or has its own litter cleanup program.

Upon receipt of your appeal form, declaration, and administrative appeal fee, the hearing officer will send you a notice of the hearing date. The hearing officer may issue any orders or impose any conditions consistent with the purposes of the Litter Fee Ordinance. The determination of the hearing officer is final.

WHAT IF I PAY LATE OR FAIL TO COMPLY?

Failure to pay the fee by the specified due date determined by the Finance and Management Agency is a violation of the ordinance. The violation will result in a 10% to 50% penalty of the fee due, and interest will accrue at one percent per month until the liability is paid.

Failure to complete the declaration and return it to the City before the due date will cause a \$50.00 non-compliance fee to be assessed against you.
