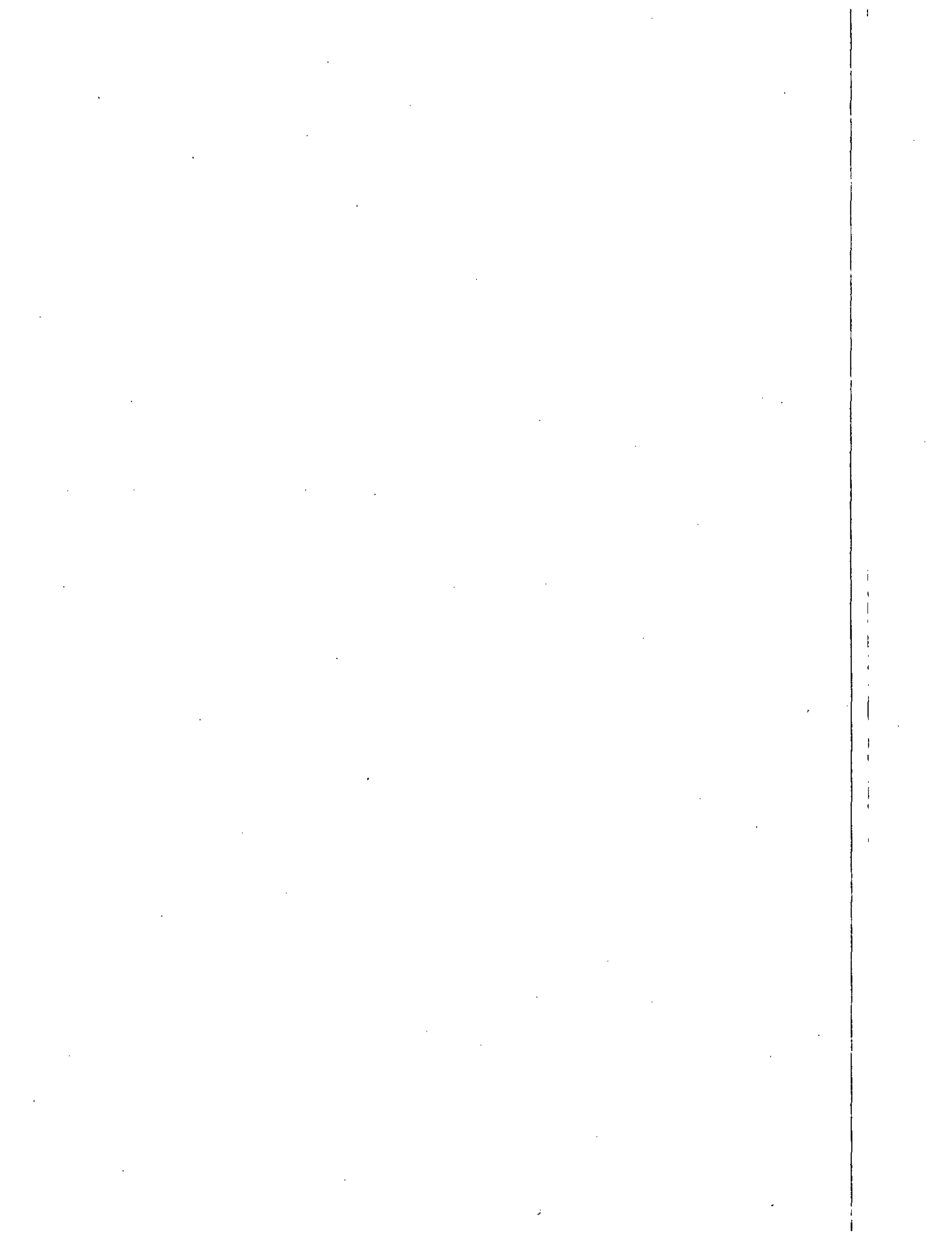

**WHEREAS**, City Charter section 601 provides that members of boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the Council; and

**WHEREAS**, City Charter section 601 also provides that the City Council may fill a vacancy on a City board or commission if the Mayor does not submit for confirmation a candidate to fill the vacancy within 90 days of the date that the vacancy first occurred; and

**WHEREAS**, the City Clerk's Office has confirmed that no vacancy notice on the Youth Advisory Commission was submitted, and that the Mayor has not submitted to the City Clerk or to the Rules Committee a candidate to fill the vacancy; and

**WHEREAS**, more than 90 days have passed since the vacancy first occurred; and

**WHEREAS**, the Ordinance No. 10545 C.M.S. established the Youth Advisory Commission; and

**WHEREAS**, the Ordinance No. 11869 C.M.S. specifies that members of the Youth Advisory Commission are to serve a two year term, and appointments to fill a term of office are only to be for the remainder of that term; now therefore, be it

**RESOLVED**, that the City Council hereby appoints the following individual to the term set forth below:
