NOTICE AND DIGEST

ORDINANCE BANNING UNSECURED FIREARMS AND AMMUNITION LOCATED IN UNATTENDED VEHICLES IN THE PUBLIC RIGHT OF WAY AND "PUBLIC PLACES" AS DEFINED IN THE ORDINANCE

This ordinance adds Chapter 9.37 titled "Oakland's Ban on Unsecured Firearms and Ammunition in Unattended Vehicles Act" to the Oakland Municipal Code. The ordinance prohibits unsecured firearms and ammunition in unattended vehicles that are parked or left standing in the public right of way and public places within the City of Oakland. Persons who do not comply with the safe storage requirements of the ordinance are subject to criminal prosecution and civil action, and may be liable for fines, penalties, costs, and other remedies provided by the ordinance and other laws. Vehicle owners and persons with control of the vehicle may also face liability.

This Ordinance was introduced at the City Council meeting, Tuesday evening **January 5, 2016**, and passed to print **8 Ayes**. Final adoption has been scheduled for the City Council meeting Tuesday evening **January 19, 2016, 5:30 p.m.**, at One Frank H. Ogawa Plaza, Council Chamber, 3rd floor, Oakland, California.
