RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO REJECT ALL BIDS AND TO RE-BID THE REHABILITATION OF SANITARY SEWERS IN THE AREA BOUNDED BY CREST, MICHIGAN AND 82ND AVENUES AND MACARTHUR BOULEVARD - SUBBASIN 84-112 (PROJECT NO. C158110), USING REVISED

STANDARD SPECIFICATIONS

SUMMARY

A resolution has been prepared authorizing the City Administrator to reject all bids and to re-bid the Rehabilitation of Sanitary Sewers in the Area Bounded by Crest, Michigan and 82nd Avenues and Macarthur Boulevard – Subbasin 84-112 (Project No. C158110). The work to be completed under this project is part of the City annual sanitary sewer rehabilitation program. The work is located in Council Districts 6 and 7.

FISCAL IMPACTS

Funding for this project is available in the Sewer Service Fund (3100); Organization 92244; Account 57417; Project C158110. The engineer's estimate for the work is \$1,620,250.

BACKGROUND

On October 13, 2003, the City Clerk received two bids for this project in the amounts of \$1,275,037 and \$1,320,630 as shown in *Attachment A*. Andes Construction, Inc. received a 5% discount as a certified SLBE bidding as a prime, making Andes Construction, Inc. the lowest bidder.

In general, the proposed work consists of replacing approximately 2,100 linear feet of existing sewer with 8" diameter VCP; replacing approximately 4,300 linear feet of existing sewer with 8" diameter HDPE; installing approximately 6,400 linear feet of existing sewer with 8" diameter line; rehabilitating or replacing over 110 sewer structures; reconnecting house connection sewers; rehabilitating house connection sewer and other related works as indicated on the plans and specifications. This project meets the Mayor/Council Goals and Citywide Objective to maintain and enhance Oakland's physical assets by providing for well-maintained sanitary sewer systems.

Since this project was advertised and bids accepted, PWA staff has made significant revisions to the Standard Specifications that deal with pipe materials, rehabilitation methods, testing of rehabilitated pipes, and connections to house laterals. These changes have a direct impact on the basis for measurements and payment for completed work and affect the construction cost of the project. Staff determined that it is more cost effective and less risky to re-bid the contract based on the new specifications.

KEY ISSUES AND IMPACTS

Staff has reviewed the submitted bids for this work and determined that the modified Standard Specifications will affect the project cost.

The modified project schedule estimates that new bids will be received and opened in August 2004 and construction to begin in October 2004. Staff will return to Council in September 2004 to award a contract to the lowest responsible bidder. The contract specifies \$1,000 in liquidated damages per calendar day if the contract completion time of 120 working days is exceeded.

DISABILITY AND SENIOR CITIZEN ACCESS

There is no direct impact or benefit to seniors or people with disabilities.

RECOMMENDATION AND RATIONALE

It is recommended that all bids for the Rehabilitation of Sanitary Sewers in the Area Bounded by Crest, Michigan and 82nd Avenues and Macarthur Boulevard – Subbasin 84-112 (Project No. C158110) be rejected and to advertise and invite new bids based on the revised Specifications.

ACTION REQUESTED OF THE CITY COUNCIL

Staff recommends that the City Council approve the resolution.
