RESOLUTION NO. 90446 = C.M.S.

RESOLUTION ACCEPTING THE DEPARTMENT OF VIOLENCE PREVENTION'S 2024 APRICOT 360 ANNUAL REPORT AND APPROVING THE AMENDED APRICOT 360 USE POLICY AS APPROVED BY THE PRIVACY ADVISORY COMMISSION ON JUNE 6, 2024.

WHEREAS, the City of Oakland's Department of Violence Prevention (DVP) has a mandate to reduce levels of group violence, intimate partner violence, commercial sexual exploitation, and trauma associated with this violence in Oakland; and

WHEREAS, the DVP funds community-based organizations (CBOs) to deliver violence prevention and intervention services using funding from the 2014 Oakland Public Safety and Services Violence Prevention Act (Measure Z) and the General Purpose Fund; and

WHEREAS, the DVP also hires and supervises staff who perform direct services in the areas of shooting and homicide response, relocation, and family coaching; and

WHEREAS, the DVP requires a data management system that is able to collect and tabulate service delivery data for funded CBOs and DVP direct service staff in order to monitor, coordinate, and evaluate funded activities; and

WHEREAS, the City Council awarded a contract to Bonterra Inc., formerly Social Solutions Global, Inc., for the term of August 1, 2022, to June 30, 2027, to build and maintain a web-based data management system for the DVP through Bonterra, Inc.'s Apricot 360 platform in an amount not to exceed Six Hundred Twenty-Four Thousand Five Hundred Ninety-Seven Dollars (\$624,597)(Resolution No. 89380 C.M.S. and Resolution No. 89797); and

WHEREAS, that the Privacy Advisory Commission's establishing ordinance (Ordinance No. 13349 C.M.S.) states that annual reports and recommendations on the use of the surveillance technology approved by the Privacy Advisory Commission will be submitted to the City Council; and

WHEREAS, the DVP's 2024 Apricot 360 Annual Report and amended Apricot 360 Use Policy were presented and approved at the June 6, 2024, meeting of the Privacy Advisory Commission; now, therefore, be it

RESOLVED: That the City Council approves the amended Apricot 360 Use Policy.
