RESOLUTION APPROVING THE 1) ESTABLISHMENT OF A NO-PARKING BETWEEN 3:00 A.M. AND 6:00 A.M. ZONE ON HEGENBERGER PLACE (BOTH SIDES) BETWEEN HEGENBERGER ROAD AND THE END; 2) ESTABLISHMENT OF A ONE-HOUR PARKING ZONE ON EAST 12TH STREET (BOTH SIDES) BETWEEN 33RD AVENUE AND 35TH AVENUE; AND 3) REMOVAL OF A NO-PARKING ZONE AND ESTABLISHMENT OF A TWO-HOUR PARKING ZONE ON PERKINS STREET (EAST SIDE) BETWEEN GRAND AVENUE AND BELLEVUE AVENUE

SUMMARY

A resolution has been prepared approving the establishment of a no-parking between 3:00 a.m. and 6:00 a.m. zone on both sides of Hegenberger Place between Hegenberger Road and the end, establishment of a one-hour parking zone on both sides of East 12th Street between 33rd Avenue and 35th Avenue, and removal of a no-parking zone and establishment of a two-hour parking zone on the east side of Perkins Street between Grand Avenue and Bellevue Avenue. Sections 10.28.180, 10.28.190, and 10.28.260 of the Oakland Municipal Code allow, by resolution, the establishment/removal of one-hour parking, two-hour parking, and no parking between certain hours, respectively, based on parking demands and community request.

The proposed parking restrictions are consistent with the following Mayor/City Council goals and citywide objectives:

Make Oakland a Safe City by improving the perception of safety.

Improve Oakland Neighborhoods by improving traffic, bike, and pedestrian safety and by enhancing neighborhood commerce.

FISCAL IMPACTS

The cost to implement the proposed installations is approximately \$4200. The Traffic Maintenance Division of the Public Works Agency will perform the work. Funds are available in the Public Works Agency's Transportation Services Division budget. The funding source is the State Gas Tax Fund (2230), under the Neighborhood Traffic Safety Program (Project No. C159610). These changes are expected to increase parking citation revenues by approximately \$5,000.

BACKGROUND

The proposed no-parking between 3:00 a.m. and 6:00 a.m. zone on both side of Hegenberger Place between Hegenberger Road and the end, and one-hour parking zone on both sides of East 12th Street between 33rd Avenue and 35th Avenue were both requested by citizens who submitted qualified petitions as required from the adjacent property owners/occupants. The proposed two-hour parking zone with removal of existing no parking zone on the east side of Perkins Street between Grand Avenue and Bellevue Avenue, which is adjacent to the Lakeside Park, was requested by a citizen and supported by the Parks and Recreation Division.

KEY ISSUES AND IMPACTS

To discourage overnight parking of recreational vehicles and trailers, the businesses on Hegenberger Place between Hegenberger Road and the end submitted a petition to install a noparking zone on both sides of the street. To increase short-term parking supply for their customers, the businesses on East 12th Street between 33rd Avenue and 35th Avenue submitted a petition to install a one-hour parking zone on both sides of the street. To increase public access to Lakeside Park, a citizen requested the removal of the existing no-parking zone and the installation of a two-hour parking zone on the east side of Perkins Street between Grand Avenue and Bellevue Avenue.

SUSTAINABLE OPPORTUNITIES

The proposed two-hour parking on East 12th Street will benefit commercial businesses by increasing short-term parking for their customers.

DISABILITY AND SENIOR CITIZEN ACCESS

Time-limited parking on East 12th Street between 33rd Avenue and 35th Avenue and on Perkins Street between Grand Avenue and Bellevue Avenue will provide more opportunities for disabled and senior citizens to find available parking closer to their destinations. Vehicles displaying a disabled placard are exempted from the time-limited parking.

RECOMMENDATION AND RATIONALE

Staff recommends approval of the resolution to establish a no parking between 3:00 a.m. and 6:00 a.m. zone on both sides of Hegenberger Place between Hegenberger Road and the end, one-hour parking zone on both sides of East 12th Street between 33rd Avenue and 35th Avenue, and two-hour parking zone with removal of existing no parking zone on the east side of Perkins Street between Grand Avenue and Bellevue Avenue.

ACTION REQUESTED OF THE CITY COUNCIL

Staff requests that Council approve the resolution.

WHEREAS, a no parking between 3:00 a.m. and 6:00 a.m. zone on both sides of Hegenberger Place between Hegenberger Road and the end has been successfully petitioned by adjacent businesses to discourage overnight parking of recreational vehicles and trailers; and

WHEREAS, a one-hour parking zone on East 12th Street between 33rd Avenue and 35th Avenue has been successfully petitioned by adjacent businesses to discourage all-day parking; and

WHEREAS, the removal of a no parking zone and the establishment of a two-hour parking zone on the east side of Perkins Street between Grand Avenue and Bellevue Avenue has been requested by the Parks and Recreation Division to increase public access to the park; now, therefore, be it

RESOLVED: That the installation of a no parking between 3:00 a.m. and 6:00 a.m. zone, one-hour parking zone, and two-hour parking zone as described below are hereby approved:

NO PARKING, ONE-HOUR AND TWO-HOUR ZONES

1. HEGENBERGER PLACE — Install no parking between 3:00 a.m. and 6:00 a.m. zone on both sides of Hegenberger Place between Hegenberger Road and the end.

- 2. EAST 12th STREET Install one-hour parking zone on East 12th Street between 33rd Avenue and 35th Avenue.
- 3. PERKINS STREET Remove no parking zone and install two-hour parking zone on the east side of Perkins Street between Grand Avenue and Bellevue Avenue.
