INTRODUCED BY COUNCILMEMBER CARROLL FIFE

RESOLUTION AWARDING A GRANT IN THE AMOUNT OF \$20,000 FROM THE DISTRICT 3 MURAL FUNDING TO ALTERNATIVE MINDS FOUNDATION, INC. AS FISCAL SPONSOR FOR AEROSOUL FOR ART INSTALLATIONS AT THE 3RD STREET AND PERALTA STREET CO-GOVERNED HOMELESS INTERVENTION SITE

WHEREAS, many local artists are out of work or experiencing limited contract opportunities as a result of the COVID-19 pandemic; and

WHEREAS, the U.S. Department of Health and Human Services through the National Institutions of Health have published scholarly reports on the positive effect of art interventions on mental health outcomes; and

WHEREAS, the District Three office understands that art interventions have been linked to healing and recovery, influencing mental, somatic, and psychological conditions (Samaritter, 2018; Mastandrea et al., 2019a); and

WHEREAS, the City Council approved a \$480,000 allocation in the Fiscal Year 2021-2023 Biennial Budget (Fund 5505) to fund murals and public art throughout the City of Oakland, pursuant to Resolution No. 88783 C.M.S.; and

WHEREAS, the mural funding is allocated to Municipal Capital Improvement: Public Arts Fund (5505), Public Art Organization (85521), Pub Art Mural Fund 5505 Project (1006167), Public Art Program (CE01); and

WHEREAS, the allocated funds were equally divided among the Council Districts at \$60,000 each; and

WHEREAS, the District Three office seeks to grant \$20,000 from the designated mural funds to Alternative Minds Foundation, Inc. for mural art installations on pallets at the 3rd Street and Peralta Street co-governed homeless intervention site; and

WHEREAS, Alternative Minds Foundation, Inc. will serve as the fiscal sponsor for AeroSoul, and work in conjunction with multiple artists and residents of 3rd and Peralta Streets, as well as volunteer housed neighbors and community to install the artwork; and

WHEREAS, in conformance with City requirements, Alternative Minds Foundation, Inc. will provide documentation for the use of these funds, including any permits or waivers required, permission from the property owner to install the murals, and review by the City's Public Art Advisory Committee (PAAC); now, therefore, be it

RESOLVED: That the City Council hereby awards a grant in the amount of \$20,000, pursuant to Resolution No. 88783 C.M.S., to Alternative Minds Foundation, Inc. serving as a fiscal sponsor for AeroSoul for the purpose of installing murals at the 3rd and Peralta co-governed homeless intervention site.


