SUMMARY

Staff recommends the City Council and the Oakland Redevelopment Agency Board (“Agency”) authorize the City/Agency Administrator to award and execute eleven professional services contracts for as-needed Real Estate appraisal services to the following individuals and companies:

FISCAL IMPACT

Each of the sixteen contracts for Tier I consultants will be for an amount not to exceed \$25,000.00 with the Agency and the City, the two contracts for the Tier II consultant will be for an amount not to exceed \$45,000.00 with the Agency and the City, and the four contracts for Tier III consultants will be for an amount not to exceed \$100,000.00 with the Agency and the City, for a total of \$890,000.00 for all twenty-two contracts. The as-needed real estate appraisal services will be required for projects funded by various Redevelopment Agency funds, or City project funds including capital improvement funds, bonds, and grants. The approval of the twenty-two contracts will not result in the additional appropriation of funds. The services will be funded through appropriations within the various individual projects. Funds will be identified prior to the performance of the appraisal services. Actual expenditures would be approved through a City Council or Redevelopment Agency appropriations process.

BACKGROUND

Many of the transactions considered by the City's Real Estate Services Division require a real estate appraisal report performed and provided by outside consultant(s). Additionally, California Redevelopment Law requires appraisals for sales transactions.

Agency Transactions

The Redevelopment Agency, through its districts, strives to reduce blight and underdeveloped property by acquisition and redevelopment of these properties. In the three previous years the Agency has spent an annual average of approximately \$120,000 on appraisal services.

City Transactions and Projects

City departments acquire property for parks, libraries, fire stations and other capital improvement projects throughout the city. Public Works Agency makes continuous improvements to streets and other infrastructure which requires acquisition of real property. In the three previous years the City has spent an annual average of approximately \$100,000 on appraisal services.

Request for Proposals (RFP)

On February 10, 2010, staff issued a Request For Proposals (RFP) for as-needed Real Estate appraisal services. Staff received twelve proposals prior to the March 3, 2010 due date. One of the twelve proposals was deemed non-responsive based on the respondent's failure to submit the required City Contracting schedules and forms.

The remaining eleven respondents were reviewed by Contract Compliance. Two respondents, J.W. Tom and Associates and Yovino-Young Incorporated, are certified City of Oakland Small Local Business Enterprises by Contract Compliance. The remaining nine respondents are not certified City of Oakland Local & Small Local Business Enterprises.

The eleven responsive proposals were evaluated by Real Estate Division staff using standard scoring criteria modified for appraisal services. All nine of the proposals scored greater than 90 out of a total 100 points. J.W. Tom and Associates and Yovino-Young Incorporated received 5 points each for its Small Local Business Enterprise certification status. Based on the quality of the proposals submitted and evaluated, the experience and qualifications of the respondents, and the scores received by the eleven respondents, staff is proposing to enter into contracts with the eleven respondents.

Table 1 provides a list of the eleven respondents in alphabetical order by company name, along with the: i) type of appraisal services provided by the company, ii) company's Local/Small Local Business Enterprise certification status, and iii) company's proposal evaluation score.

KEY ISSUES AND IMPACTS

- 1) Staff is proposing to enter into twenty-two contracts. Each company would enter into a contract with the Agency and another contract for the same amount with the City. Each of the twenty-two contracts would be for a three year term.
- 2) Staff is proposing to enter into contracts with Tier I companies in a not to exceed amount of \$25,000. Staff is proposing to enter into a contract with the Tier II company, Margaretta J. Darnall, in an amount not to exceed \$45,000 because Margaretta J. Darnall is unique in that it specializes in appraisal services for government agency transactions. Finally, staff is proposing to enter into contracts with Tier III companies, J.W. Tom and Associates and Yovino-Young, Incorporated, in an amount not to exceed \$100,000, because both companies are certified as Small Local Business Enterprises and previous work product from these two companies has been reviewed on a continuous project to project basis by Real Estate Division staff and has been found to be exceptional.
- 3) If the attached resolutions are approved, staff would on a project by project, as-needed basis, issue project descriptions, to the appraisal companies under contract with the appropriate experience, qualifications and capacity for the project, requesting a written proposal and cost estimate to complete the needed appraisal work. The Real Estate Services Division Manager would select and issue a work order to the appropriate appraisal company he deemed best able to complete the needed appraisal services.

PROGRAM DESCRIPTION

The Real Estate Services Division, in support of the City of Oakland and the Oakland Redevelopment Agency, provides real estates services for various acquisition and disposal transactions, and special projects throughout the City of Oakland as part of Agency and City's ongoing acquisition and sale programs.

SUSTAINABLE OPPORTUNITIES

Economic: This report and its requested actions do not provide any specific sustainable economic opportunities.

Environmental: This report and its requested actions do not provide any specific sustainable environmental opportunities.

Social Equity: This report and its requested actions do not provide any specific sustainable social equity opportunities.

DISABILITY AND SENIOR CITIZEN ACCESS

The proposed project has no direct impact on access by seniors and people with disabilities.

RECOMMENDATIONS AND RATIONALE

Staff recommends the City Council and the Agency Board authorize the City/Agency Administrator to award and execute twenty-two professional services contracts for as-needed Real Estate appraisal services. Professional, outside Real Estate appraisal services are needed to support various Agency and City projects. The award and execution of the twenty-two as-needed Real Estate appraisal services contracts will allow the Real Estate Services Division to provide necessary appraisal services to the Agency and City staff in an efficient and timely manner. Based on historical precedence, staff anticipates projects will occur throughout the city over the next three-year period and will require Real Estate appraisal services.

ALTERNATIVE RECOMMENDATIONS


The City Council and the Agency Board could authorize the City/Agency Administrator to execute only one-year appraisal services contracts, and require staff to complete RFPs on an annual basis. Completing an RFP process on an annual basis entails additional staff time and resources and additional costs, time and resources for the respondents; given this, staff does not recommend the alternative of contracts for one year only.

Reducing the number of contracts and/or the not-to-exceed amounts for each contract would not reduce the total amount expended by the City/Agency on real estate appraisal services, as these appraisal costs are required as part of many City/Agency real estate transactions, regardless of the contracting arrangements, and are funded through the specific transaction budgets.

ACTION REQUESTED OF THE CITY COUNCIL

Staff requests that the City Council and Agency Board approve the attached resolutions.
