INTRODUCED BY COUNCILMEMBER ABEL GUILLEN

RESOLUTION AUTHORIZING COUNCILMEMBER ABEL GUILLEN TO TRAVEL TO NASHVILLE, TENNESSEE TO ATTEND THE 2015 NATIONAL LEAGUE OF CITIES ANNUAL CONFERENCE AND EXPO FROM NOVEMBER 4-7, 2015

WHEREAS, Councilmember Abel Guillen, the City of Oakland's delegate to the National League of Cities Annual Meeting taking place in Nashville, Tennessee on November 7, 2015, wishes to represent the City of Oakland at the 2015 National League of Cities Annual Conference and Expo from November 4-7, 2015; and

WHEREAS, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation is \$382.99 (air) and up to \$100 (ground); lodging is \$1296.19; per diem is \$168; and conference registration fee is \$469.00; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

WHEREAS, Councilmember Guillen seeks Council approval of the aforementioned estimated costs to travel to Nashville, Tennessee to attend the 2015 National League of Cities Annual Conference and Expo, November 4-7, 2015; now, therefore, be it

RESOLVED: That all expenses incurred for said travel are hereby authorized.
