**RESOLUTION AMENDING RESOLUTION NO. 90099 C.M.S., WHICH COMMEMORATIVELY RENAMED RUDSDALE STREET, TO CORRECT THE STREET DESIGNATION AS FOLLOWS: RENAMING RUDSDALE STREET FROM 82ND AVENUE TO 78TH AVENUE AS 'GLADYS GREEN WAY' AND RENAMING RUDSDALE STREET FROM 77TH AVENUE TO INTERNATIONAL BOULEVARD AS 'TEDDIE RADFORD WAY', PURSUANT TO THE POLICY AND CRITERIA ESTABLISHED BY OAKLAND CITY COUNCIL RESOLUTION NO. 77967 C.M.S.**

**WHEREAS**, the City Council adopted Resolution no. 90099 C.M.S. on February 20, 2024, commemoratively renaming Rudsdale Street from 76<sup>th</sup> Avenue to 79<sup>th</sup> Avenue as “Gladys Green and Teddie Radford Way”; and

**WHEREAS**, the City Council would now like to amend the street designation to commemoratively rename Rudsdale Street from 82nd Avenue to 78th Avenue as “Gladys Green Way”, and commemoratively rename Rudsdale Street from 77th Avenue to International Boulevard as “Teddie Radford Way”; and

**WHEREAS**, an application has been submitted by the Office of Councilmember Treva Reid requesting the commemorative street naming of Rudsdale Street from 82<sup>nd</sup> Avenue to 78th Avenue be renamed as “Gladys Green Way”, and requesting the commemorative street naming of Rudsdale Street from 77<sup>th</sup> Ave to International Boulevard be renamed as “Teddie Radford Way”; and

**WHEREAS**, California Government Code section 34091.1 allows a jurisdiction by resolution to name a new public street or to rename an existing public street; and

**WHEREAS**, the naming of a new public street or the renaming of an existing public street is exempt from the California Environmental Quality Act of 1970; and

**WHEREAS**, the City Council will occasionally honor the contributions of an outstanding individual with commemorative street names or by the renaming of a public street, such as Joe Morgan Way, Herbert Guice Way, Peter Van Kleef Way, Dr. Huey P. Newton Way, Deontae Bush Way, Dorothy King Way, and Too \$hort Way; and

**WHEREAS**, pursuant to Oakland City Council Resolution No. 77967 C.M.S. (passed July 15, 2003), the City Council may, on its own motion, consider the renaming of a public street as a tribute to an individual, or as a result of a significant event or activity if one of the following criteria is met: (1) The individual has positively impacted the lives of a nation or the world; or (2) The name change is related to an economic development or redevelopment activity; or (3) The renaming commemorates a significant historical event; and

**WHEREAS**, the City Council may commemorate a nominee either by: (a) retaining the existing street name and installing commemorative plaques or signs; or (b) renaming the existing street for the individual and installing new street signs; and

**WHEREAS**, the City Council finds that Mrs. Gladys Green and Mrs. Teddie Radford, longtime friends and acclaimed community members, have positively impacted many lives in the City of Oakland and across the world, and merit commemoration both individually and as a whole; and

**WHEREAS**, the late Mrs. Gladys Green left an unforgettable mark on her hometown of Oakland and in Alameda County. She led out incredibly strong as a neighborhood activist, business leader, and advocate for low-income and underserved residents for over 70 years as well as helping champion successful efforts to curb gun violence in Oakland. Mrs. Green served willingly and diligently as a member of several local and regional bodies. She was dedicated to serving her immediate neighborhood and deeply committed to helping others and making Oakland a better place to live, work, and play. Leveraging her strong influences in the community, Mrs. Green developed excellent relationships with the City of Oakland, Alameda County, state-elected officials, department heads, and management in all the municipalities that impact Oakland. Her track record and long history of public service speak for themselves. Her ability to advance stakeholder concerns to actionable items will be admired for years to come. Mrs. Green served as the Board Chair of the Alameda County-Oakland Community Action Partnership (AC-OCAP), which works to eliminate poverty and blunt its impacts. For more than a decade, she organized monthly food giveaways and a holiday toy drive for families and children at St. Benedict's Church, where Mrs. Green was an active member and an electoral and Eucharistic minister. Mrs. Green was a longtime member and Vice Chair of the Board of the Oakland Business Development Corporation, which provides loans and consultation to help launch small businesses. She successfully helped launch Oakland's Pican and Bakesale Betty restaurants. Mrs. Green was also the President of the Elmhurst Community Development Board for Oakland's District 7 and a member of the Coliseum Redevelopment Advisory Committee, where she advocated for keeping a sports franchise in Oakland for economic stability. Mrs. Green's dedication to community service has been recognized by numerous awards and honors over the years. A courageous leader in her efforts to promote public safety, in 1999 she was honored by the State of California for her work on legislation that broadened restrictions on assault weapons, and worked with the Oakland Unified School District on programs seeking to remove guns from school campuses. In February of 2015, Mrs. Green was recognized by former Councilmember Larry Reid as the District 7 Black History Month Honoree. That same year, she was inducted into the Alameda County Women's Hall of Fame as the "Community Service" inductee. Mrs. Green made countless significant contributions in her community, in the city of Oakland, and regionally. Her every action demonstrated her deep commitment to public service, civic engagement, and being a champion for our city's residents. Leaving behind an astounding

legacy of incredible work and a positive impact from her service, on Monday, March 28,2022, Mrs. Green went home to be with the Lord.

**WHEREAS**, the late Teddie L. Radford was born on February 18, 1925, in Camden, Texas. She was the ninth of ten children and often remarked that working on the family farm in Camden alongside her siblings instilled in her strength of body and mind, resilience, and an appreciation of all life had to offer. In 1950 when her husband, Tommie L. Radford, was called to serve our country, the family relocated to Oakland, California, and settled in the family home at 78th Avenue and Rudsdale Street. In 1952, Mrs. Radford joined and remained an active member of Allen Temple Baptist Church. She was an original member of the former Chancel Choir, sang in the Sanctuary and Mass Choirs and was actively involved with the Mary C. Williams Circle. She was also a personal sponsor of the Allen Temple Little League Baseball Program. Although her various volunteer roles within the East Oakland community are too vast to list, Mrs. Radford was also a notably fierce community activist, advocating for the safety and well-being of her neighbors and neighborhood. She served as the Co-Chair of the Rudsdale Safety Coalition, as a member and officer of the Board of Directors for Oakland’s City Council District 7-Elmhurst District Board and was an active leader of the non-profit Oakland Community Organizations. Mrs. Radford was also an early advocate for the development of the East Oakland Senior Center. In addition to being a loving child of God, a wife, and a mother, Mrs. Radford worked for over twenty years at Sunshine Biscuits, at a time when factories in District 7 thrived. On June 5, 2018, Mrs. Radford peacefully ascended to take her place with our Lord God.

**WHEREAS**, the City Council intends to honor the contributions of both Mrs. Gladys Green and Mrs. Teddie Radford to the Oakland community by retaining the existing street names, adding additional honorary street names, and installing commemorative street signs or plaques; and

**WHEREAS**, the City Council intends that the costs associated with such commemorative acts will be borne by Councilmember Treva Reid’s office; now, therefore, be it

**RESOLVED:** That the Oakland City Council hereby approves the commemorative renaming of Rudsdale Street from 82nd Avenue to 78th Avenue as “Gladys Green Way,” and be it

**FURTHER RESOLVED:** That the Oakland City Council hereby approves the commemorative renaming of Rudsdale Street from 77<sup>th</sup> Avenue to International Boulevard as ‘Teddie Radford Way’; and be it

**FURTHER RESOLVED:** That the Oakland City Council directs the City Administrator to proceed with the commemorative designations of ‘Gladys Green Way’ and ‘Teddie Radford Way’ and placement of street signs or plaques to that effect on Rudsdale Street from 77th Avenue to 82nd Avenue upon payment of costs.
