RESOLUTION AUTHORIZING A PROFESSIONAL SERVICES AGREEMENT WITH WOLFE MASON ASSOCIATES FOR ENVIRONMENTAL, GEOTECHNICAL AND RELATED DESIGN SERVICES FOR THE LAKE MERRITT DEMONSTRATION WETLANDS PROJECT IN AN AMOUNT NOT TO EXCEED ONE HUNDRED FORTY ~~NINE~~ THOUSAND FIVE HUNDRED DOLLARS (\$149,500)

WHEREAS, the City of Oakland has adequate funding from the Measure I Interest account and a California Coastal Conservancy grant for design of a demonstration wetlands project; and

WHEREAS, on July 30, 1996 City Council by Resolution No. 72879 C.M.S. affirmed support for development and authorized application of funding from the California Coastal Conservancy for demonstration wetlands at Lake Merritt; and

WHEREAS, Wolfe Mason and Associates will provide complete plans, specifications, permit assistance and cost estimates for the development of demonstration wetlands at Lake Merritt; and

WHEREAS, Wolfe Mason Associates was chosen through the City's Request for Proposal process as the top-rated and most qualified firm to provide the services; and

WHEREAS, the City Council finds that this contract is for services of a professional nature; and

WHEREAS, the City Council finds that the services under the contract will be temporary; and

RESOLVED: That the City Manager is hereby authorized to enter into ~~an~~ agreement with Wolfe Mason Associates to provide professional services associated with design of demonstration wetlands at Lake Merritt in an amount for basic services not-to-exceed One Hundred Thirty Thousand Dollars (\$130,000); and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to exceed the amount for basic services for unforeseen contingencies in an amount not to exceed Nineteen Thousand Five Hundred Dollars (\$19,500); and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to approve any subsequent amendments to or extensions of said agreement except those involving compensation or the allocation of additional funds provided that such amendments or extensions shall be filed with the City Clerk's Office; and be it

FURTHER RESOLVED: That a copy of the agreement will be on file in the City Clerk's Office and will be approved for form and legality by the Office of the City Attorney.
