

**RECOGNIZING THE ZEALOUS LEADERSHIP OF FOREVER

WHEREAS, in 2014 a new brand was created, Forever Oakland, with the intent to keep Oakland Raiders in Oakland; and

WHEREAS, in June 12th, 2017 was the first conference at Oakland City Hall and introduced lawyers Jim Quinn with Berg and Androphy; and

WHEREAS, Forever Oakland worked tirelessly behind to enlist the support of the JPA, the Alameda County Board of Supervisors and the Oakland City Council for months, to finally get the Oakland City Council to Vote, " to become a Client " for Jim Quinn of Berg and Androphy and to file a anti trust lawsuit against the NFL and the Oakland Raiders; and

WHEREAS, on December 11th, 2018 City of Oakland followed the lead and instruction of the Forever Oakland and filed an anti trust lawsuit against the NFL and the Oakland Raiders; and

WHEREAS, Forever Oakland with twenty years of experience will continue of hosting Charity events year round to Make Oakland Better and Make Others Better; and


