RESOLUTION AUTHORIZING COUNCIL MEMBER DESLEY BROOKS TO TRAVEL TO WASHINGTON D.C. TO ATTEND THE 2015 NATIONAL LEAGUE OF CITIES CONGRESS OF CITIES AND EXPOSITION MARCH 7-11, 2015

WHEREAS, Council Member Desley Brooks, is a member of the Economic Development Steering Committee and the Council on Youth, Education, and Families Policy Groups of the National League of Cities, and Exposition in Washington D.C. from March 7, 2015 to March 11, 2015; and

WHEREAS, pursuant to City Council resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation (including airfare and taxis/ ground transportation) is \$512.00, of lodging is \$1123.04 for four nights, of per diem is \$280.00 for five days, of conference registration fees is \$795.00; and

WHEREAS, in compliance with the requirement to identify the source of funding in Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project Councilmember Brooks' office funds; and

WHEREAS, Council Member Desley Brooks seeks Council approval of the fore mentioned estimated costs to travel to Washington D.C. to attend the 2015 National League of Cities Congress of Cities and Exposition from March 7th -March 11th, 2015; now, therefore, be it

RESOLVED: That all expenses incurred for said travel are hereby authorized.


