RESOLUTION AWARDING GRANTS TO SIXTY (60) OAKLAND-BASED NONPROFIT ORGANIZATIONS PROVIDING ARTS AND CULTURAL SERVICES IN OAKLAND FOR FISCAL YEAR 2023-24, IN A TOTAL AMOUNT NOT TO EXCEED ONE MILLION THREE HUNDRED TWENTY-SEVEN THOUSAND DOLLARS (\$1,327,000)

WHEREAS, in 1985, the City Council adopted the first arts funding policies and procedures for the City of Oakland (City), establishing a panel system of evaluating funding proposals and distributing City funds to the arts; and

WHEREAS, the Cultural Funding Program, housed in the Economic and Workforce Development Department, is the City's funding mechanism to support Oakland-based nonprofit organizations and artists providing arts and cultural activities to the public; and

WHEREAS, the mission of the Cultural Funding Program is to fund Oakland-based art and cultural activities that reflect the diversity of the City for citizens of and visitors to Oakland, focusing on the key areas of general support, neighborhood arts, and arts education, through two grant making categories for Cultural Organizational Assistance, and Neighborhood Voices for Festivals; and

WHEREAS, in October 2023, the Cultural Funding Program convened community review panels to evaluate submitted applications for Neighborhood Voices for Festivals and Cultural Organization Assistance grant programs. The highest scoring applications were reviewed by staff who have recommended to City Council that these grants for Fiscal Year 2023-24 Cultural Funding be awarded in the amounts listed in the below table; and

WHEREAS, Fiscal Year 2023-24 funds for the Cultural Funding Program are available as follows: \$947,000 in General Purpose Fund (1010), Cultural Arts & Marketing Org (85511), Cultural Arts Grant Fund Project (1000166); \$380,000 from the Transient Occupancy Tax surcharge, which will be reserved for arts grants in the Measure C: Transient Occupancy Tax (TOT) Surcharge Fund (2419), Cultural Arts & Marketing Org (85511), TOT Surcharge: Cultural Grants Project (1000458); and

WHEREAS, staff recommends that the City Council award grants to specific nonprofit organizations, as set forth in the below table:
