The Honorable Mayor, Oakland City Council, and Fellow Oakland Residents:

On behalf of the members of the Citizens' Police Review Board (CPRB) and the CPRB staff, I am pleased to present you with the CPRB's 2003 Annual Report. 2003 was a year of transitions and changes. The Board welcomed three new Board members as well as four new staff members — including a new Executive Director.

2003 was a productive year which included improvements in CPRB's processes and services. For example, the Board increased the number of evidentiary hearings it held from 11 hearings in 2002 to 14 hearings in 2003. Additionally, the Board resolved a total of 82 complaints — a 90% increase over the 43 complaints resolved in 2002.

One of the highlights for Board members in 2003 was the Board's first annual retreat. The retreat provided Board members and staff the opportunity to meet in an informal setting and set goals. This process was invaluable in promoting teamwork among the Board members and its staff and in laying a foundation for the Board's future work.

Finally, the Board made two policy recommendations to the Oakland Police Department in 2003. These recommendations pertain to OPD's crowd control policies and OPD's need for a policy ensuring the safety of individuals whose cars have been towed by OPD.

This year's annual report provides you with an analysis of the complaints filed in 2003 and the complaints resolved by the Board in 2003. A new section has been added to the report regarding the number of officers with one or more complaints. The report also provides you with an update on the Board's prior recommendations and information about the Board's 2003 recommendations. Finally, this year's report is better able to track patterns and trends than previous reports because the staff has collected data to track trends over a two-year period; 2002 and 2003. With this data, you may now compare the difference in data results from 2003 only and data from the two year period.

We look forward to the year ahead as we strive to make additional gains in providing the public with a means for airing its grievances and concerns and to promote increased community/police relations. Thank you for your continued support.

Executive Summary

The Citizens' Police Review Board is authorized to "exercise jurisdiction over all citizen complaints concerning the conduct of Oakland Police Officers and Park Rangers that are filed with the Board or with the Oakland Police Department." (City Ordinance No. 12454 C.M.S., section 5 (A)). Pursuant to this authority, the Board is required to submit a statistical report to the Public Safety Committee "regarding complaints filed with the Board, the processing of these complaints and their dispositions" at least twice a year. (City Ordinance 12454 C.M.S., section 6 (C)(3)).

In 2003, 117 individuals filed 105 complaints with the Citizens' Police Review Board. These individuals were primarily African-Americans and/or males, many of whom were between the ages of 25-44 years old.

The top three types of allegations filed with the Board in 2003 were: (1) officers used excessive force; (2) officers engaged in improper verbal conduct (e.g., rude comments, profanity, threats); and (3) officers failed to perform their duties in some way.

The alleged incidents occurred most frequently in Council District 3, followed by Council Districts 7 and 1. Pages 11 and 12 of this report provide a graphical depiction of the

alleged incident locations by Council District, Police Service Area and Police Beat.

In 2003, the Board resolved 82 complaints, either through administrative closure or evidentiary hearing. The Board closed 68 complaints through administrative closure and incrementally increased the number of hearings it held each calendar quarter, totaling 14 hearings held in 2003.

The Board sustained 17% of the allegations it heard and concluded that the officers were justified in their behavior for two percent of the allegations. The Board found that seven percent of the allegations it heard did not occur and voted to not sustain 74% of the allegations.

In 2003, The Board forwarded disciplinary recommendations arising from 10 complaints to the City Manager. The City Manager upheld the Board's disciplinary recommendations (either in whole or in part) from nine of those complaints.

In 2003, the Board also recommended changes to OPD's policies in the areas of its crowd control policy and its lack of a policy for providing rides to individuals whose cars have been towed by OPD.

In 2003, the CPRB staff developed and implemented a new database, enabling the agency to better track patterns and trends. For example, staff was able to determine that, in 2003 alone, four officers each received four complaints, eight officers each received two complaints, and seventy-eight officers each received one complaint.

Finally, in 2003, Joyce Hicks was appointed as the CPRB's new Executive Director. At the beginning of her tenure, Ms. Hicks proposed a 90-day plan for improving the effectiveness and efficiency of the CPRB. She hired two new investigators to fill the vacant positions and worked with the Mayor's Office to fill the vacant regular Board member positions. Additionally, Ms. Hicks worked with the Board to develop a process for holding 3-member panel hearings to increase the number of hearings provided to the public. She was able to implement the process in November 2003. Furthermore, Ms. Hicks developed a working relationship between staff at the CPRB, members of OPD, and members of the community so as to better collaborate on achieving joint goals.

2003 was an exciting year for the Board and its staff. Though it brought many changes to the agency, it also brought with it new faces and new energy to revitalize its

mission and purpose. In 2004, the Board and its staff anticipate additional improvements as they continue to assess the agency's processes and the services the agency should provide to the public.

INTRODUCTION

Purpose of this Report

Oakland City Council Ordinance No. 12454 C.M.S., section 6(C)(3) requires the Citizens' Police Review Board (CPRB) to "issue a detailed statistical report to the Public Safety Committee regarding complaints filed with the Board, the processing of these complaints and their dispositions" at least twice a year. This report is submitted pursuant to that requirement.

CPRB History

Oakland's City Council established the Citizens' Police Review Board in April 1980, with the purpose of reviewing certain complaints of misconduct by police officers or park rangers, conducting fact-finding investigations, and making advisory reports to the City Manager. On July 30, 1996, the City Council expanded the Board's original jurisdiction to include complaints involving: (1) the excessive use of force; or (2) communications of bias based upon an individual's legally protected status (race, gender, national origin, religion, sexual orientation or disability). (City Ordinance 11905 C.M.S, section 5(A)(1).) Simultaneously, the City Council also granted the Board supplemental jurisdiction over other non-force conduct (City Ordinance 11905 C.M.S., section 5(B)(1)), subpoena power over police officers and park rangers (City Ordinance 11905 C.M.S., section (G)(2)), and authorization to mediate final

and binding resolution of complaints. (City Ordinance 11905 C.M.S., section 7.)

In 2002, Oakland's City Council further expanded the Board's jurisdiction and powers. On July 30, 2002, the City Council granted the Board original jurisdiction over all complaints filed against an Oakland police officer or park ranger and expanded the Board's size from nine members to twelve members, with three of the nine members to serve as alternates. (City Ordinance 12454 C.M.S, section (3)(B)(2).) Additionally, the City Council granted the Board the option of holding evidentiary hearings via three-member panels (City Ordinance 12454 C.M.S., section 6(G)(11)) and permitted Board members to review confidential records from the Oakland Police Department (OPD) in closed session. (City Ordinance 12454 C.M.S., section 6(F)(4).) Finally, on July 30, 2002, the City Council added a policy analyst to the Board's staff and required the Board to make complaint forms available to members of the public at libraries, resource centers, and recreation centers. (City Ordinance 12454 C.M.S., section 6(E)(1).) On November, 12, 2002, the City Council further refined the amendments to the CPRB ordinance and legislated the following: the CPRB staff may make recommendations to the City Manager regarding cases that

are in litigation (City Ordinance No. 12454 C.M.S., section 6(G)(10)(b)); CPRB investigations may take up to 180 days from the initial date of filing as opposed to the previously legislated 60 days (City Ordinance No. 12454 C.M.S., section 6(G)(8)); and OPD's Internal Affairs Division and the CPRB will use the same complaint form with sequential numbering. (City Ordinance No. 12454 C.M.S., section 5(B)).

ANALYSIS OF COMPLAINTS FILED IN 2003

Number of Complaints Filed in 2003

In 2003, the CPRB received 105 complaints, a 55% increase over the 67 complaints the agency received in 2002. *Figure 1* below, shows the number of complaints filed each month in 2003.



The greatest number of complaints were filed in the month of October.

Number of Complaints Filed in 2002 and 2003

Since it is difficult to identify patterns or trends using only data from a one year period, *Figure 2* provides the number of complaints filed in a two year period, in 2002 and 2003. *Figure 2* shows that the peak filing periods during this two-year period occurred in May, August, and October.



Race and Gender of 2003 Complainants

In 2003, 117 complainants were associated with the 105 complaints that were filed with the Board. Sixty-three percent of the complainants were African-American and, when race is not considered, 54% of the complainants were male. *Figure 3*, below, provides a breakdown of the race and gender of the 2003 complainants.

Combined Data From 2002 and 2003

An analysis of the combined data from 2002 and 2003 shows a consistent trend: 61% of the complainants were African-American and, when race is not considered, 55% of the complainants were male.

Age of 2003 Complainants

In 2003, a large number of complainants were concentrated between the ages of 25-44 years old: 44% of the complainants fell within this age group. See *Figure 4* for a detailed breakdown of the complainants' ages.

Allegations Filed in 2003

In 2003, the CPRB received the highest percentage of complaints in the areas of: (1) excessive force (37%); (2) improper verbal conduct (32%); and (3) failure to act (21%). See *Figure 6*, below, for additional information.



In 2003, the largest number of alleged incidents occurred in Council Districts 3 (35%), 7 (16%), and 1 (13%). See *Figure 8* for the number and proportion of alleged incidents that occurred in the other Council Districts.

Locations of Alleged Incidents in 2002 and 2003

Figure 9 on the following page maps the specific alleged incident locations from the 2002 and the 2003 complaints. It depicts the areas of concentration, within each Council District, that the alleged incidents occur. For example, it is interesting to note that, for District 3, most of the alleged incident locations occur on the East side of the District; while for District 1, most of the alleged incident locations occur on the West side of the District.

Figure 10 depicts the same information according to Police Service Area and Police Beats.

Police Department**



Oakland Police Department



Time of Alleged Incidents in 2003

Figure 11 below shows the time periods the alleged incidents occurred. It shows that the greatest number of incidents occurred between 12:00 p.m.-2 p.m. and, after that, the next peak period occurs between 4 p.m.-6 p.m.



Time of Alleged Incidents in 2002 and 2003



Interestingly, when the data from 2002 and 2003 is combined, the analysis shows somewhat different results. Incident times peak between:

- 12:00 p.m.-2:00 p.m.,
- 4:00 p.m.-6:00 p.m., and between
- 8:00 pm-12:00 a.m.

COMPLAINTS RESOLVED IN 2003

Number of Complaints Resolved in 2003

In 2003, the Board resolved 82 complaints — 14 through evidentiary hearings and 68 through administrative closures. *Figure 13* provides the number of complaints resolved each calendar quarter.



The Board was scheduled to hold an additional three evidentiary hearings in 2003. However, the hearings were cancelled because: the first hearing (scheduled for January 23, 2003) lacked a quorum of Board members; a subject officer had a sudden family emergency on the date of the second hearing (scheduled for October 9, 2003); and the complainant failed to appear for the third hearing (scheduled for November 6, 2003).

Number of Complaints Resolved in 2002

In 2002, the Board resolved 43 complaints — 11 through evidentiary hearings and 32 through administrative closure. Thus, in resolving 82 complaints in 2003, the Board increased its productivity by 90%.

Figure 14 provides the Board's productivity per calendar quarter in 2002.



Evidentiary Hearings

Evidentiary hearings are a very important part of the Board's work. They allow the Board to identify the areas of officer misconduct and to identify officers who may need to receive some form of discipline for their behavior. Additionally, in identifying areas in which officers may be injuring the public in some way, the Board may identify policies that it would like to see changed or improved. If this is the case, the Board and its staff will hold a policy hearing and work with members of the police department to bring about the desired improvements or changes. Ultimately the goal of all the work the Board does is to improve community / police relations and maintain a professional police department.

Allegations Before the Board at Evidentiary Hearings

In 2003, the Board heard 14 complaints at evidentiary hearings. *Figure 15*, on the following page, lists the types of allegations heard at each hearing.

Board Findings at Evidentiary Hearings

In hearing these 14 complaints at evidentiary hearings, the Board sustained 17% of the total allegations it heard. These sustained allegations arose from nine of the complaints. The Board also concluded that officers were justified in two percent of the allegations it heard. The Board found that seven percent of the allegations it heard did not occur and voted to not sustain 74% of the allegations. *Figure 16*, on the following page, displays the Board's specific findings and disciplinary recommendations.

Definitions for Board Findings

This key provides definitions for the four types of findings the Board makes. The Board is required to use the "preponderance of evidence standard" in weighing evidence. This standard requires the Board to determine whether it is "more likely than not" that the allegations are true.

Sustained: At least five Board members concluded that the act(s) alleged by the Complainant occurred.

Exonerated: At least five Board members concluded that the act(s) alleged by the Complainant occurred. However, the act(s) were justified, lawful or proper.

Unfounded: At least five Board members concluded that the alleged act(s) did not occur.

Not Sustained: Based on the evidence provided at the hearing, the Board members were unable to determine whether the alleged act(s) occurred or not.

Board Findings and Allegations for Complaints Presented at Evidentiary Hearings

Board Findings by Allegation Category

Figure 17, on the following page, provides the same information as *Figure 16* but by allegation category instead of by complainant. It shows that the Board sustained multiple allegations asserting improper entry/search and allegations that officers used profanity or made rude statements. The Board also exonerated officers of two allegations — one involving an improper citation and the other involving an improper vehicle tow. Finally, the Board found some allegations to be unfounded. Those allegations asserted an improper citation, the use of force, and the planting of evidence. See *Appendix B* for an analysis of the Board's findings between 2002 and 2003.

Disciplinary Recommendations and the City Manager's Decisions

The ultimate goal of the Board's evidentiary hearings is to determine what really happened — to provide members of the public with a forum to air their complaints and to have Oakland residents make findings of fact. If the Board sustains an allegation and determines that an alleged act (more likely than not) occurred, it may forward a disciplinary recommendation to the City Manager pertaining to the subject officer of that allegation. The purpose of the recommendation is to suggest that the City Manager impose the recommended discipline to deter and prevent future similar acts and to correct and punish past misconduct.

In 2003, the Board forwarded disciplinary recommendations regarding sustained allegations from 10 complaints. *Figure 18*, below, displays the City Manager's decisions regarding these disciplinary recommendations. The City Manager agreed with the majority of the Board's recommendations, either in full or in part.

Administrative Closures

In 2003, the Board closed 68 complaints through administrative closure. *Figure 19*, below, provides the reasons for the administrative closures.




3304 Statute of Limitations**Expired**

Almost half of the complaints were closed because the one-year statute of limitations for bringing disciplinary action against a peace officer had expired. California Government Code section 3304 states in part:

"[N]o punitive action . . . shall be undertaken for any act, omission, or other allegation of misconduct if the investigation of the allegation is not completed within one year of the public agency's discovery by a person authorized to initiate an investigation of the allegation of an act, omission or other misconduct."

The Board closed 31 cases because the statute of limitations had expired. The graph below displays the 3304 expiration periods for the complaints that were closed in 2003 because the statute of limitations expired.

**Complainant was Uncooperative**

Sometimes a complainant will fail to respond to an investigator's requests for an interview or will fail to contact the office again after the complainant has filed a complaint. In these instances, the complaint may be administratively closed because of the complainant's failure to cooperate with the investigation of the complaint.

A Hearing Would not Facilitate the Fact-Finding Process

The complaints that fall under this category include those in which:

- (a) the investigator is unable to find corroborating evidence of the allegations;
- (b) the investigation fails to uncover which officers were involved; or
- (c) the allegations are obviously implausible.

OFFICER INFORMATION

Number of Officers with One or More Complaints

One of the CPRB's goals is to identify and track officers who are having problems. One way to do this is by observing officers who have received multiple complaints during a short time period. Though a complaint against an officer does not necessarily mean that the officer is having problems, if an officer receives multiple complaints within a short time period, the complaints may be an indicator of a possible problem. *Figure 20*, below, shows the number of officers with multiple complaints in 2003. (See Appendix C for a list of the number of officers who have appeared at Board hearings as subject officers).

Figure 21 is based on data from a two year period, 2002-2003. This data shows that some officers have received four, five or six complaints within two years.

BOARD AND STAFF ACTIVITIES

Getting the Basics in Place

Much of 2003 was spent doing in-house cleanup – with the hiring of new staff, including a new Executive Director, the appointment of new Board members, and the streamlining of the CPRB processes to enable the agency to run more efficiently.

In March 2003, the Mayor and the City Manager appointed Joyce Hicks as the CPRB's new Executive Director. Ms. Hicks has been an employee with the City of Oakland for 26 years. Prior to joining the CPRB, she was the Deputy Executive Director of the City's Community and Economic Development Agency and before that she was the Chief Assistant City Attorney for the City Attorney's Office.

The Board and its staff faced a number of challenges in 2003, including staff vacancies, Board vacancies, a complaint backlog and the need to increase the number of complaints the Board processed. To address these issues, Ms. Hicks proposed a 90-day plan for improving the CPRB's efficiency. *See Appendix D* for a copy of her 90-day plan.

The Board saw major changes and improvements in 2003. In March 2003, the investigative staff consisted of one investigator and two vacant investigator positions. By September 2003, all three inves-

tigator positions were filled and currently remain filled.

The next goal was to work with the Mayor's office to fill three vacant regular Board member positions. The last time that the Board had a full Board of 9 regular Board members was in September 2002. All vacancies for regular Board member positions were filled by June, 2003.

The Board accepted procedures for holding three-member panel hearings. The purpose of creating this new structure is to allow the Board to provide the public with a greater number of hearings per year. The CPRB held its first three-member panel hearing in November 2003.

Goals were proposed for the Board's yearly meeting schedule as follows:

- 10 full Board evidentiary hearings;
- 14 three-member panel hearings; and;
- 5 training or policy hearings;

totaling 29 Board meetings per year.

The CPRB held its first annual retreat in November 2003. The retreat provided the Board and its staff with an opportunity to: better understand stakeholder perspectives (such as those of the community and the police department), get to

know one another better, and develop goals for the CPRB. One of the Board's proposed goals was to develop a mission statement for the agency, which it did in early 2004. *See Appendix E* for a copy of the minutes from the Board retreat.

Other 2003 accomplishments included finalizing the use of a joint CPRB/IAD complaint form, an updated CPRB website, new complaint priorities and a new CPRB brochure.

Additional Activities

"As representatives of the community, our goal is to . . . increas[e] understanding between community members and police officers . . ."

In an attempt to better understand the needs of the communities they represent, the Board and its staff co-hosted an outreach meeting with Council Member Nancy Nadel's office in West Oakland in January 2003. The purpose of the meeting was: (1) to inform residents in West Oakland about the CPRB's services; and (2) to give Board members an opportunity to hear the specific concerns of people who live in West Oakland.

Additionally, the CPRB staff has been working with representatives from People United for a Better Oak-

land (PUEBLO), the Police Department and the City Attorney's office to implement a City-wide survey to learn about: (1) customer satisfaction with police services; and (2) what percentage of people, who have negative experiences with the police, file complaints with the CPRB. The latter information will enable the Board and its staff to determine how well the complaints it receives reflect the general feeling among Oakland residents and also to determine where to focus its future efforts.

"As representatives of the community, our goal is to . . . ensure police accountability . . ." — CPRB mission statement.

One way for the Board to ensure police accountability is to identify patterns and trends in the complaints it receives and then to report out this information in its bi-annual reports. In 2003, the CPRB staff implemented its database for this purpose.

The following list provides examples of the type of information the database currently contains:

- The specific allegations against each officer;
- The number of sustained allegations against each officer;

- Disciplinary recommendations made regarding each officer;
- The officers' supervisors on the dates of the alleged incidents;
- The officers' patrol assignments on the dates of the alleged incidents;
- The total number of complaints against each officer.

Additionally, the CPRB staff is in the process of revising the database to be able to track the litigation costs associated with each officer in the near future.

One way the CPRB staff promotes this part of the Board's mission is to participate in task forces affecting the Police Department. For example, the Director participates in the monthly Monitor meetings regarding the settlement agreement negotiated in *Delphine Allen v. City of Oakland et al.*, No. C00-4599 TEH (JL). Additionally, the Director sat as a non-voting member of OPD's Major Incident Board of Review to review the Police Department's response to the April 7, 2003 war protest at the Port of Oakland.

Furthermore, both Ms. Hicks and

Policy Analyst/Outreach Coordinator Wendy Jan participate in the Police Department's Racial Profiling Task Force. The purpose of the task force is to create an anti-racial profiling policy for the Police Department and to analyze data to determine whether officers in the Department are currently engaging in racial profiling. Finally, the Director and Policy Analyst/Outreach Coordinator participated in the Police Department's consistency of discipline working group.

Training

Board Training

In 2003, Board members received three training sessions regarding the following topics:

1. California's "open meeting" law;
2. The settlement agreement negotiated in *Delphine Allen v. City of Oakland et al.*, No. C00-4599 TEH (JL); and
3. OPD's Use of Force policy.

Staff Training

In 2003, Executive Director Joyce Hicks and Policy Analyst/Outreach Coordinator Wendy Jan attended a conference held by the National Association for Civilian Oversight of Law Enforcement Agencies (NACOLE) in Los Angeles, CA. Additionally, Ms. Hicks and the staff's investigators attended a three-day

training course on conducting internal affairs investigations. And, Ms. Hicks and other staff members participated in police ride-alongs in 2003.

2003 RECOMMENDATIONS

OPD's Crowd Control Policy

Background

On April 10, 2003, and subsequently on December 11, 2003, the Board heard testimony from members of the public regarding police conduct during a war protest that took place at the Port of Oakland on April 7, 2003. The protestors complained that they were engaging in a non-violent protest and that the police used excessive force in attempting to disperse the crowd. Many protestors alleged injuries.

At the meeting on December 11, 2003, the Board invited Police Chief Richard Word to inform the Board of his efforts to address the protestors' complaints. Chief Word explained that he had convened a task force to examine the incident; he listed the task force's recommended policy changes, which he said he was in the process of reviewing. Additionally, the Board invited Jerry Harper, a crowd control expert, to speak about best practice crowd control methods being used by other police departments around the nation.

Board Recommendations

At the conclusion of the meeting, the Board made three recommendations and one request:

First, the Board recommends that the Police Department eliminate its use of wooden dowels. Second, the

Board recommends that the Police Department end its practice of using the sting grenade. Third, the Board recommends that Executive Director Joyce Hicks and Chief Word collaborate with community representatives to further work on revising OPD's crowd control policy. And finally, the Board requested that Chief Word keep the Board updated about future policy changes concerning this issue.

OPD's Tow Policy and Ensuring the Safety of Drivers and Passengers

Background

In 2003, the Board heard three complaints, and received a fourth complaint, alleging that police officers are towing individuals' cars but leaving the drivers and the passengers in the streets without a ride. All incidents occurred after dark. The Police Department does not have a formal policy addressing this issue.

Board Recommendation

Given the potential threat of danger to individuals left on the street without a means home, as well as the fact that teenagers have been left stranded, the Board recommends that the Police Department draft a comprehensive training bulletin regarding procedures to be followed

when vehicles have been towed — taking into consideration the age of the individual, the location of the tow and the ability of the individual to relocate to a safe location. The training bulletin should also include the directive that an officer should offer the individual and passengers transportation to the Eastmont Substation or the Police Administration Building, whichever is closer, if leaving the individual or their passengers at the location of the tow would place them at risk of harm.

UPDATE ON PRIOR RECOMMENDATIONS

The chart on the next few pages lists the status of the recommendations made by the Board between 2000 and 2002. The Police Department implemented four out of six of the recommendations that were resolved this year. The fifth resolved recommendation was denied because it was thought to be impractical in terms of officer safety and the sixth resolved recommendation was already an OPD practice. Five of the recommendations are awaiting action from OPD. And one recommendation cannot be implemented because of budget constraints.

The recommendations that are marked as having been "resolved" will not appear in future annual reports. However, those that are marked "pending action by OPD" or "to be followed up on in the future" will continue to be tracked in future annual reports.


In sum, 2003 was a very productive year for the Board. The Board and its staff look forward to 2004, to continue to improve its processes and the services it provides to members of the public.

These results are slightly different from the results obtained when analyzing the 2003 data alone. In 2003, the third largest category of complaints alleged the failure to act instead of improper entry or search.

RE: Report from Executive Director

Over the past three weeks, I have conducted a preliminary analysis of the CPRB operations. Based on this analysis, I have concluded that effective operation of this Board will require at minimum that the following steps be implemented within the next ninety days:


- 1) Hire one additional investigator by May 1, 2003
- 2) Work with Mayor's Office to obtain full complement of board members
- 3) Implement 3-member panels to meet on alternate weeks from Board meetings
- 4) Set a goal for panels and full Board to hear at least three cases a month – for a combined total of 36 cases a year
- 5) Reserve one full Board meeting a month to hear the highest priority cases
- 6) Reserve six full Board meetings a year to hear policy matters, develop policy recommendations, receive training and receive reports from City staff, including OPD staff
- 7) Implement streamlined investigative processes and report writing
- 8) Conduct thorough review of outstanding caseload
- 9) Propose dismissal of cases where the Government Code section 3304 one year statute has run
- 10) Propose early dismissal of cases where a hearing would not facilitate the fact-finding process and good cause has not been shown for further action
- 11) Encourage mediation or conciliation for remaining cases not set for hearing
- 12) Hire one or two additional investigators to begin July 1, 2003 (While the ordinance proposes, as the budget permits, one investigator per one hundred police officers, which would total eight investigators, the City's budget will not permit a full complement of investigators at this time)
- 13) Conduct facilitated one half day or all day Saturday retreat with the Board
- 14) Present 2002 Annual Report to Board on April 10, 2003

- 15) Present 2002 Annual Report to City Council Public Safety Committee on May 6, 2003
- 16) Present 2002 Annual Report to City Council on May 20, 2003
- 17) Evaluate current database
- 18) Explore cost of case management system
- 19) Examine performance measures and propose new ones if necessary
- 20) Update CPRB website at:

These proposals are for your consideration and input. At the conclusion of ninety days, I will report back to you on implementation of these proposals or any others of your choosing. As proposals are implemented in the interim, I will report to you periodically.
