RESOLUTION NO. 90729 C.M.S.

RESOLUTION ADOPTING THE FISCAL YEAR 2025-2027 PUBLIC ART PROJECTS PLAN AND THE 2023-2024 PUBLIC ART ACTIVITIES REPORT

WHEREAS, the City of Oakland's Public Art (Ordinance No. 11086 C.M.S.), adopted in 1989 (amended in 2019: Ordinance No. 13562 C.M.S.), established the Public Art Program, the Public Art Advisory Committee, and requirements for adoption of a Public Art Projects Plan; and

WHEREAS, the Public Art Projects Plan must include project descriptions, budgets, locations, and recommended design approaches for projects; and be developed by Cultural Affairs Division staff, in consultation with appropriate City capital project staff, before submission to the Public Art Advisory Committee and City Council for approval and implementation; and

WHEREAS, the Public Art Project Account within the Cultural Affairs Division budget receives the 1.5% appropriated from capital improvement project (CIP) budgets, funds contributed to the City from private developers as in-lieu contributions, and private contributions to the public art program; and

WHEREAS, the Fiscal Year (FY) 2025-2027 Public Art Projects Plan was developed by Cultural Affairs Public Art Program staff in coordination with financial and capital project management staff of the City's Public Works Agency-Project Delivery Division, and Department of Transportation-Planning and Project Delivery (see Attachment A to the staff report accompanying this Resolution); and

WHEREAS, on March 3, 2025, the Public Art Advisory Committee approved the FY 2025-2027 Public Art Projects Plan and 2023-2024 Public Art Activities Report; and

WHEREAS, many of the projects in the Public Art Projects Plan have funds previously appropriated as part of the CIP program, and no further appropriation is required, however certain in-lieu public art contributions and other contributions in the Public Art Project Account have not been previously appropriated for specific projects; now, therefore, be it

RESOLVED: That the City Council adopts the FY 2025-2027 Public Art Projects Plan and 2023-2024 Activities Report.
