

### RESOLUTION DECLARING THE RESULTS OF THE CITY OF OAKLAND SPECIAL MUNICIPAL ELECTION HELD ON TUESDAY, APRIL 15, 2025

**WHEREAS**, pursuant to California law and section 1102 of the Charter of the City of Oakland, a Special Municipal Election was duly held in the City of Oakland on Tuesday, April 15, 2025; and

**WHEREAS**, the Alameda County Registrar of Voters has prepared and submitted a certified Statement of the Results of all the votes cast for each office and measure and a copy of the Official Canvass for said Special Municipal Election; and

**WHEREAS**, the City Clerk has examined the above returns of said Special Municipal Election and has, in presenting this Resolution to the City Council, certified the results of the Special Municipal Election, which are attached hereto as **Attachment A**; and

**WHEREAS**, California Elections Code sections 10263 and 15400 provide that the governing body shall declare the results of each election under its jurisdiction as to the persons elected and the measures voted on at the election; now, therefore, be it

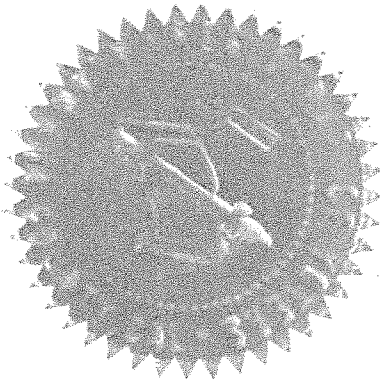
