**RESOLUTION AUTHORIZING THE CITY MANAGER, ON BEHALF OF THE CITY OF OAKLAND, TO EXECUTE AN AGREEMENT WITH THE CALIFORNIA COMMISSION ON PEACE OFFICER STANDARDS AND TRAINING (POST) FOR THE PURPOSE OF PERMITTING THE POLICE DEPARTMENT TO PRESENT THE POST CERTIFIED ACADEMY RECRUIT TRAINING OFFICER COURSE UP TO THREE TIMES TO SEVENTY-TWO (72) STUDENTS, AND TO RECEIVE UP TO EIGHT THOUSAND ONE HUNDRED THIRTY DOLLARS AND THIRTY- THREE CENTS (\$8,130.33) IN REIMBURSEMENT FUNDS**

**WHEREAS,** The California Commission on Peace Officer Standards and Training (POST) has requested that the City of Oakland Police Department present the POST certified Academy Recruit Training Officer (RTO) Course to California Law Enforcement personnel who are appointed to the position of Academy Recruit Training Officer; and

**WHEREAS,** POST will reimburse the City for up to three presentations of the course, not to exceed 72 total students, up to a maximum amount of \$8,130.33, during the period of July 1, 2002 through June 30, 2003; and

**WHEREAS,** it is in the best interests of the City of Oakland to execute an agreement with POST for the purposes described above; and

**WHEREAS,** the City of Oakland has executed similar agreements with POST since 1991; now, therefore, be it

**RESOLVED:** That the City Manager or his designees is hereby authorized to submit and execute an agreement between the City of Oakland and POST for the purposes described above; and be it

**FURTHER RESOLVED:** That the City Manager or his designees is authorized to accept reimbursement funds from POST for deposit to the General Purpose Fund, No. 1010, in OPD Training Org. code: 103430.
