**RESOLUTION AUTHORIZING THE CITY MANAGER ON BEHALF OF THE CITY OF OAKLAND TO EXECUTE A PROFESSIONAL SERVICES AGREEMENT IN AN AMOUNT NOT TO EXCEED \$26,500 BETWEEN THE CITY AND CAROLYN MANGRUM, TO PROVIDE CONSULTING SERVICES TO ASSIST THE OAKLAND HEAD START PROGRAM TO RECONFIGURE ITS GOVERNANCE STRUCTURES TO CONFORM WITH NEW FEDERAL REGULATIONS**

WHEREAS, since 1972 the City of Oakland has been, and is, the local grantee for the Oakland Head Start Program; and

WHEREAS, the City Council of the City of Oakland serves as the Governing Board of the Oakland Head Start Program; and

WHEREAS, the City Council, by its action of December 12, 2000, has resolved to reconfigure the governance structure of Oakland Head Start in order to conform to new federal regulations; and

WHEREAS, the City will require specialized consultant assistance to carry out the said reconfiguration; and

WHEREAS, the City Council finds that this contract shall not result in the loss of salary or employment by anyone having permanent status in the competitive service; and

WHEREAS, the City Council finds that the performance of this service is in the best interest of the City because of economy; and

WHEREAS, Carolyn Mangrum, an Oakland-based, woman-owned, minority sole proprietorship, is recommended by Region IX of the Head Start Bureau of the U.S. Department of Health and Human Services to offer consulting services to assist Head Start Programs to reconfigure their governance structures to conform with new federal regulations; now, therefore, be it

RESOLVED: That the City Council authorize the City Manager to execute a Professional Services Agreement in an amount not to exceed \$26,500 between the City and Carolyn Mangrum to provide consulting services to assist the Oakland Head Start Program to reconfigure its Governance structures to conform with new federal regulations; and, be it

RESOLVED: That funding is available in the Head Start Program Budget to cover the cost of these services in fund 2128, organization 78231, account 54919 and project G15160; and, be it

FURTHER RESOLVED: That the City Council hereby authorizes and directs the City Manager or his agent to negotiate and execute said Agreement with Carolyn Mangrum; and, be it

FURTHER RESOLVED: That a copy of the executed Agreement shall be filed with the City Clerk of the City of Oakland.
