RESOLUTION CONFIRMING AND RATIFYING ACTION TAKEN BY THE MAYOR DURING THE OAKLAND CITY COUNCIL 2024 ANNUAL RECESS IN CONFORMANCE WITH THE COUNCIL'S RULES OF PROCEDURE

WHEREAS, pursuant to the City Council's Rules of Procedure, established by Resolution No. 90066 C.M.S., the City Council's Annual Recess shall be for the period of August 1 through August 31 of each year, or until the first meeting in September as set by the Rules and Legislation Committee; and

WHEREAS, the City Council has taken its 2024 Annual Recess from August 1, 2024, through the first meeting in September; and

WHEREAS, pursuant to the Council's Rules of Procedure, the Mayor is authorized to take certain actions on behalf of the City Council during the Annual Recess, and the Mayor is directed to bring a report to the City Council, at its first regular meeting in October, of actions taken by the Mayor during the Annual Recess and the City Council may confirm said actions of the Mayor; and

WHEREAS, the following actions were taken during the Annual Recess:

- Adopt A Resolution Fixing the Rate of Property Tax and Levying a Tax on Real and Personal Property in The City of Oakland for Fiscal Year 2024-2025 For Voter-Approved Indebtedness (Resolution No. 90393 C.M.S.);
- Adopt A Resolution Authorizing the City Administrator to Enter into A Cooperative Purchase Agreement With the Ford Store for The Acquisition of Oakland Police Department Vehicles in An Amount Not to Exceed Five Hundred Thousand Dollars (\$500,000), And Making California Environmental Quality Act (CEQA) Exemption Findings (Resolution No. 90394 C.M.S.);
