INTRODUCED BY COUNCIL MEMBER JEAN QUAN

**RESOLUTION AUTHORIZING A GRANT FROM COUNCILMEMBER QUAN'S PAY-GO FUNDS TO THE LAUREL DISTRICT ASSOCIATION IN THE AMOUNT OF FIVE THOUSAND DOLLARS (\$5,000.00) FOR PLACEMENT OF 48 CONTAINER PLANTERS ALONG MACARTHUR BOULEVARD IN CONNECTION WITH PHASE II, LAUREL DISTRICT STREETScape IMPROVEMENT PROJECT**

**WHEREAS**, Laurel District Association has obtained and provided 48 Container Planters with their own funds to be placed at strategic sidewalk locations on MacArthur Boulevard in connection with the City of Oakland Phase II Laurel District Streetscape Improvement Project; and

**WHEREAS**, Councilmember Jean Quan wishes to reimburse this organization out of her pay-go fund account and match a portion of Laurel District Association's expenditure; and

**WHEREAS**, Laurel District Association collaborated with Laurel residents, merchants, and property owners in their Business Improvement District's Public Rights of Way and Streetscape Character Committee to promote a more pedestrian friendly ambiance and beautify the City sidewalks in the Laurel District; and

**WHEREAS**, The City will require the Laurel District Association to provide documentation for reimbursement from Councilmember Quan's Pay-Go funds; now, therefore, be it

**RESOLVED:** That the City Council authorizes the grant of \$5,000 from Councilmember Quan's Pay-Go funds to the Laurel District Association for 48 container planters along MacArthur Boulevard; and, be it

**FURTHER RESOLVED:** That the City Administrator is authorized to execute an appropriate grant agreement with the Laurel District Association with the purposes of the grant, subject to approval as to form and legality by the City Attorney.
