INTRODUCED BY COUNCILMEMBER BROOKS

RESOLUTION AUTHORIZING A GRANT OF \$1500.00 FROM COUNCILMEMBER Desley Brooks' PRIORITY PROJECT FUNDS to the Oakland, California, Babe Ruth League for Expenses Associated with two members of the All Star Team participating in the 2008 College Tour; and

WHEREAS, On June 8, 2006, the City Council did amend the 2005-2007 Policy Budget for the City of Oakland to include \$250,000 a piece for the Mayor and each councilmember to use as priority funds for projects in the City of Oakland or in council members' districts subject to City Council approval; and

WHEREAS, Councilmember Brooks wishes to grant a portion of her priority project funds to Oakland, California, Babe Ruth League for Expenses Associated with two members of the All Star Team participating in the 2008 College Tour; and

WHEREAS, The City will require Oakland, California, Babe Ruth League to provide documentation for use of the Councilmember's priority project funds; now, therefore, be it

RESOLVED: That the City Council authorizes the grant of \$1500.00 Councilmember Brooks' priority project funds to Oakland, California, Babe Ruth League for Expenses Associated with two members of the All Star Team participating in the 2008 College Tour; and, be it

FURTHER RESOLVED: That the City Administrator is authorized to execute an appropriate grant agreement with Oakland, California, Babe Ruth League consistent with the purposes of the grant, subject to approval as to form and legality by the City Attorney.
