# OAKLAND CITY COUNCIL

## RESOLUTION NO. 905297 C.M.S.

**RESOLUTION: (1) AUTHORIZING THE CITY ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH ALLIANCE LAUNDRY SYSTEMS FOR COMMERCIAL GRADE WASHING MACHINE AND APPLIANCE SERVICES FOR THE FIRE DEPARTMENT, FROM JUNE 1, 2024 THROUGH JUNE 30, 2028, AT A COST OF FIVE HUNDRED THOUSAND DOLLARS (\$500,000) WITH THE OPTION TO EXTEND THE AGREEMENT FOR ONE ADDITIONAL YEAR, WITHOUT RETURNING TO COUNCIL, AT A COST OF ONE HUNDRED THOUSAND DOLLARS (\$100,000), FOR A TOTAL AMOUNT NOT TO EXCEED SIX HUNDRED THOUSAND DOLLARS (\$600,000); AND (2) WAIVING THE CITY'S COMPETITIVE REQUEST FOR PROPOSALS/QUALIFICATION (RFP/Q) PROCESS AND LOCAL AND SMALL LOCAL BUSINESS (L/SLBE) ENTERPRISE PROGRAM REQUIREMENTS FOR THE PROPOSED AGREEMENT**

**WHEREAS**, research over the last decade or more has shown that occupational cancer continues to be a significant concern in the fire service: the composition of items found in residential and commercial structures that burn are highly toxic; and

**WHEREAS**, personal protective equipment are important items that allow Oakland firefighters to perform their job responsibilities during emergency situations, and the ability for firefighters to wash/clean their PPE after a fire or hazardous material response incident is imperative; and

**WHEREAS**, Fire Department members in the Operations Division respond to over 70,000 emergency calls for service each year, and routine cleaning of PPE provides a high level of protection from carcinogens that can lead to occupational cancer; and

**WHEREAS**, an International fire service best practice is that all PPE items are washed in a commercial extractor/washing machine immediately after a fire incident to reduce the likelihood of an OFD member being exposed unnecessarily to contaminants; and

**WHEREAS**, this Resolution will authorize the City Administrator to establish a contract with Alliance Laundry Systems for extractor purchasing, servicing, and yearly maintenance; and

**WHEREAS**, at its core, an extractor is a device that is used to remove harmful fumes and compounds from the gear used by firefighters, the Oakland Fire Department has been using this proven safety equipment for over 25 years; and

**WHEREAS**, adoption of this resolution is in alignment with the citywide goal of holistic community safety, as it directly benefits the health, safety and wellbeing of Oakland Firefighters; and

**WHEREAS**, the Local Business Enterprise/Small Local Business Enterprise ("LBE/SLBE") Program (Ordinance No. 13647 C.M.S.) requires a minimum 50-percent (50%) and participation for all professional service contracts valued at or over fifty thousand dollars (\$50,000) when there are at least three certified businesses listed in the industry, trade, or profession that constitutes a major category of work; and if at least three L/SLBEs are not certified, then the requirement is either waived, or the 50% requirement may be set at a percentage from 50 % to 0%, but not less than 20% if at least one LBE/SLBE is certified and available; and

**WHEREAS**, The Oakland Fire Department (OFD) Support Services Division is responsible for the procurement of PPE and appliances used to clean the gear after it has been contaminated, and the acquisition of appliances used to clean PPE items ensures the City and the Fire Department remain compliant with National Fire Protection Association (NFPA) 1851 (Standard on Selection, Care, and Maintenance of Protective Ensembles for Structural Fire Fighting and Proximity Fire Fighting) and Occupational Safety and Health Administration (OSHA) mandates; and

**WHEREAS**, Alliance Laundry Systems has demonstrated consistency and reliability with supplying needed fire equipment items to the Oakland Fire Department in the past; and

**WHEREAS**, Oakland Municipal Code Section 2.04.051.B. permits the City Council to waive the request for proposal/qualifications (RFP/Q) requirements upon a finding that it is in the best interest of the City to do so; and

**WHEREAS**, the Fire Department is seeking to waive the RFP/Q requirements as well as the ("LBE/SLBE") requirements for the proposed agreement due to the fact that Alliance Laundry Systems is the only provider in Northern California who can supply extractors for department use and conduct repairs/maintenance in a timely manner yet is not a local business, and

**WHEREAS**, the City Council already appropriated and allocated funding in the FY 2024-25 midcycle budget for the current year of the contract in General Purpose Fund (1010), Fire: Support Services Organization (20816), DP200 Administrative Project (1000009), Emergency Response Support Services (PS26); and

**WHEREAS**, funding for the future years of the contract are contingent on funding availability and approval in future budget cycles; now, be it

**RESOLVED:** That the City Administrator is authorized to enter into a four-year agreement with Alliance Laundry Systems to purchase personal protective gear extractors (commercial grade washing machine) and appliance servicing from June 1, 2024 through June 30, 2028 for an amount not to exceed \$500,000, with the option to extend for one additional year, without returning to City Council, for an amount not to exceed \$100,000 for a grand total amount not to exceed \$600,000; and, be it

**FURTHER RESOLVED:** That for the reasons stated above and in the City Administrator's report accompanying this item and pursuant to Oakland Municipal Code section 2.04.051.B, the City Council finds that it is in the best interests of the City to waive the advertising and the request for proposal/qualifications and the LBE/SLBE requirements for the proposed agreement with Alliance Laundry Systems, and so waives such requirements; and be it

**FURTHER RESOLVED:** That all agreements issued hereunder shall be reviewed and approved by the office of the City Attorney for form and legality and copies shall be placed on file in the Office of the City Clerk.


