RESOLUTION AUTHORIZING AWARD OF A CONTRACT TO AJW CONSTRUCTION FOR CITY-WIDE SIDEWALK REPAIR (PROJECT No. C78020) IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED SEVENTY-NINE THOUSAND SIX HUNDRED TEN DOLLARS (\$1,879,610)

WHEREAS, on November 18, 2002, five bids were received by the Office of the City Clerk of the City of Oakland for City-Wide Sidewalk Repair (Project No. C78020); and

WHEREAS, **AJW CONSTRUCTION** is the lowest responsible bidder for the project and has met the Local Business Enterprise/Small Local Business Enterprise requirements; and

WHEREAS, there are sufficient funds in the amount of \$1,879,610 for construction of the work in Project C78020, Fund 5500, Organization 92452, and the engineer's estimate for the work is \$1,984,000; and

WHEREAS, the City lacks the equipment and qualified personnel to perform the necessary work; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive services; now, therefore be it

RESOLVED: That the contract for City-Wide Sidewalk Repair (Project C78020) is hereby awarded to **AJW Construction**, in accordance with the terms of its bid therefore, dated November 18, 2002 for the amount of One Million Eight Hundred Seventy-Nine Thousand Ten Dollars (\$1,879,610); and be it

FURTHER RESOLVED: That the amount of the bond for faithful performance, \$939,805, and the amount for a bond to guarantee payment of all claims for labor and materials furnished and for amount due under the Unemployment Insurance Act, \$1,879,610, with respect to such work are hereby approved; and be it

FURTHER RESOLVED: That the City Manager is hereby authorized to enter into a contract with **AJW Construction**, on behalf of the City of Oakland and to execute any amendments, extensions or modifications of said agreement, within the limitations of the project specifications; and be it

FURTHER RESOLVED: That all other bids are hereby rejected; and be it

FURTHER RESOLVED: That the Contract shall be reviewed and approved by the City Attorney and placed on file in the Office of the City Clerk; and be it

FURTHER RESOLVED: That the City Clerk is hereby directed to post conspicuously forthwith notice of the above award on the official bulletin board in the Office of the City Clerk; and be it

FURTHER RESOLVED: That the approval of this Resolution requires a two-thirds vote of the Council members.
