RESOLUTION AUTHORIZING THE CITY MANAGER, ON BEHALF OF THE CITY OF OAKLAND, TO EXECUTE AN AGREEMENT WITH THE CALIFORNIA COMMISSION ON PEACE OFFICER STANDARDS AND TRAINING (POST) FOR THE PURPOSE OF PERMITTING THE POLICE DEPARTMENT TO PRESENT THE POST CERTIFIED EMERGENCY VEHICLE OPERATIONS COURSE (EVOC) TO ONE HUNDRED TWENTY (120) OFFICERS, AND TO RECEIVE UP TO FIFTY-THREE THOUSAND FOUR HUNDRED DOLLARS (\$53,400) IN REIMBURSEMENT FUNDS, AT A RATE OF FOUR HUNDRED FORTY-FIVE DOLLARS (\$445) PER STUDENT

WHEREAS, The California Commission on Peace Officer Standards and Training (POST) has requested that the City of Oakland Police Department present the POST certified Emergency Vehicle Operations Course (EVOC) to California Law Enforcement personnel who are full-time, on-duty employees of POST reimbursable agencies; and

WHEREAS, POST will reimburse the City for each full-time, on-duty POST reimbursable student that attends a City of Oakland POST presentation at a rate of \$445 per student, up to a maximum amount of \$53,400 during the period of July 1, 2002 through June 30, 2003; and

WHEREAS, it is in the best interests of the City of Oakland to execute an agreement with POST for the purposes described above; and

WHEREAS, the City of Oakland has executed similar agreements with POST since 1995; now, therefore, be it

RESOLVED: That the City Manager or his designees is hereby authorized to submit and execute an agreement between the City of Oakland and POST for the purposes described above; and be it

FURTHER RESOLVED: That the City Manager or his designees is authorized to accept reimbursement funds from POST for deposit to the General Purpose Fund: 1010, in OPD Training Org. code: 103430.
