## INTRODUCED BY COUNCILMEMBERS REBECCA KAPLAN AND ROWENA BROWN

RESOLUTION TO (1) COMMEMORATIVELY NAME THE TO BE INSTALLED BIKEWAY ALONG LAKESHORE AVENUE BETWEEN EL EMBARCADERO AND EAST 18TH STREET AS THE "MAIA CORREIA MEMORIAL BIKEWAY" AND (2) AUTHORIZE THE INSTALLATION OF A MEMORIAL PLAQUE DEDICATED TO MAIA CORREIA PURSUANT TO THE GUIDANCE ESTABLISHED BY OAKLAND CITY COUNCIL RESOLUTION NO. 77967 C.M.S

**WHEREAS,** California Government Code section 30492 allows a jurisdiction by resolution, order, or other instrument to adopt, establish or change the name of any street, boulevard, park, or place; and

**WHEREAS,** the naming of a new public street, boulevard, park, or place or renaming of an existing public street, boulevard, park, or place is exempt from the California Environmental Quality Act (CEQA) of 1970; and

**WHEREAS,** Maia Correia, a vibrant four-year-old, was riding in the back of her father's bicycle on Lakeshore Avenue near Hanover Street when a driver opening their door into the bike lane caused them to crash in August 2023; and

**WHEREAS,** Maia suffered a head injury and, in the following days, succumbed to that injury at Children's Hospital. Maia's family and community celebrated her life cut short, and mourned her passing as the fifteenth traffic death in 2023; and

WHEREAS, in immediate response to this tragedy, the Oakland Department of Transportation (OakDOT) developed and installed signs reminding motorists to "check for bikes" before opening car doors per California Vehicle Code 22517 under OakDOT's Rapid Response Program that investigates all traffic crashes fatal to pedestrians or bicyclists and seeks near-term design solutions; and

WHEREAS, Maia's tragic death has galvanized her family as active advocates, along with bike safety organizations, residents, and city officials, to make ongoing improvements in bicycling safety and conditions around Lake Merritt, one of the most utilized recreation areas in Oakland; and

**WHEREAS,** the City of Oakland's 2019 Bicycle Plan proposes separated bike lanes on Lakeshore Avenue along Lake Merritt; and

**WHEREAS**, the District 2 Office of Councilmember Rebecca Kaplan and the At-Large Council Office of Rowena Brown, along with former District 2 Councilmember Nikki Fortunato Bas, find the life and legacy of Maia Correia should be honored and recognized; and

**WHEREAS**, the City Council intends to honor Maia Correia by retaining the existing street name and installing a commemorative plaque or sign for the separated bikeway under construction in her memory; and

**WHEREAS,** currently there is no formal policy or procedure in place for naming bike paths in the City of Oakland, and Resolution 77967 relating to public street naming was used as guidance until the City develops or adopts a policy or procedure for naming bike paths; and

WHEREAS, the City Council intends that the costs associated with such a commemorative act will be borne in partnership between the Offices of Councilmembers Rebecca Kaplan and Rowena Brown; now, therefore, be it

**RESOLVED:** That the City Council declares that the commemorative name for the separated bikeway along Lakeshore Avenue between El Embarcadero and East 18th Street shall be named the "Maia Correia Memorial Bikeway"; and be it

**FURTHER RESOLVED:** That the Oakland City Council directs the City Administrator to proceed with the commemorative designation of the Maia Correia Memorial Bikeway and placement of sign(s) or plaque(s) to that effect along the separated bikeway to be constructed on Lakeshore Avenue between El Embarcadero and East 18th INSUCUNCIL, OAKLAND, CALIFORNIA,
