RESOLUTION NO. 88642 C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR, OR DESIGNEE, TO ACCEPT AND APPROPRIATE DONATED FUNDS IN AN AMOUNT NOT TO EXCEED NINETY-SIX THOUSAND DOLLARS (\$96,000.00) FROM THE FRIENDS OF OAKLAND ANIMAL SERVICES TO FUND A TEMPORARY CONTRACT SERVICE EMPLOYEE VETERINARIAN POSITION FOR A ONE-YEAR PERIOD.

WHEREAS, Oakland Animal Services ("OAS") largely serves Oakland citizens who lack the financial resources to provide veterinary care for their pets; and

WHEREAS, OAS has budgeted one full-time equivalent Veterinarian position which is filled; and

WHEREAS, OAS intakes nearly 6,000 animals annually but lacks adequate veterinary capacity to provide these animals with proper medical care; and

WHEREAS, on May 19, 2020, by Resolution No. 88128 CMS, the Oakland City Council approved the acceptance of \$96,000 from Friends of Oakland Animal Services to fund a one-year contract for a Temporary Contract Service Employee ("TCSE") Veterinarian, from July 1, 2020 to June 30, 2021; and

WHEREAS, Friends of Oakland Animal Services has agreed to donate \$96,000 to allow OAS to continue to fund a TCSE Veterinarian position for up to 960 hours for a one-year period from July 1, 2021 to June 30, 2022, at no expense to the City of Oakland; and

WHEREAS, Having additional in-house veterinary capacity will allow OAS to provide support to people who love their animals but lack the resources to provide necessary veterinarian care, including people who are experiencing homelessness, to keep people and animals together; now, therefore, be it

RESOLVED: That the City Administrator, or designee, is authorized to accept and appropriate donated funds from Friends of Oakland Animal Services in an amount not to exceed ninety-six thousand dollars \$96,000.00 to fund a TCSE Veterinarian for up to 960 hours for a one-year period; and be it

FURTHER RESOLVED: That the City Administrator is authorized to complete all negotiations and complete all contracts, amendments, modifications and extensions consistent with this resolution and its basic purposes.


