RESOLUTION NO. _____ C.M.S.

RESOLUTION:

- (1) **AUTHORIZING THE CITY ADMINISTRATOR TO ACCEPT AND ENTER INTO A CALIFORNIA ENERGY COMMISSION RESPONSIVE, EASY CHARGING PRODUCTS WITH DYNAMIC SIGNALS (“CEC REDWDS”) GRANT AGREEMENT WITH EVENERGI, LLC IN THE AMOUNT OF ONE HUNDRED NINETEEN THOUSAND AND ONE HUNDRED FIFTY-SEVEN DOLLAR (\$119,157), FOR THE INSTALLATION OF THREE EV CHARGERS, SOFTWARE DEVELOPMENT AND SUBSCRIPTIONS OF CHARGING MANAGEMENT SOLUTIONS SOFTWARE; AND**
- (2) **ADOPTING APPROPRIATE CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) FINDINGS**

WHEREAS, per City Resolution No. 77842 C.M.S., adopted on June 3, 2003, that City of Oakland will develop and implement “Green Fleet” policy and directed the staff to purchase vehicles powered by alternative fuels whenever possible, and actively pursue federal, state, and other incentive program related to clean air and energy efficiency; and

WHEREAS, per City Resolution 88268 C.M.S., adopted on July 28, 2020, that City shall establish goal to achieve community-wide carbon neutrality no later than 2045; and

WHEREAS, City Resolution 90511 C.M.S., was adopted on November 12, 2024, to accept grants from Pacific Gas & Electric (PG&E) for the upgrading EV charger’s infrastructure and Resolution 90576 C.M.S. was adopted on December 17, to accept \$2,300,000 grant fund from California Energy Commission (CEC) for installation of 100 EV chargers throughout the City, these resolutions build on the City’s longstanding commitment to fleet electrification and its 'Green Fleet' policy, as established in Resolution 77842 C.M.S."; and

WHEREAS, with 1,570 on-road vehicles in the City’s fleet in its fleet and five fleet sites, fleet electrification planning, such as assessing fleets, fleet replacement options, fueling and charging needs, infrastructure siting, costs and impacts, and transition actions are necessary; and

WHEREAS, to accommodate the growth of electric vehicles’ fuel needs, the installation of EV charging stations is necessary; and

WHEREAS, Oakland Public Work has been awarded a California Energy Commission Responsive, Easy Charging Products with Dynamic Signals (CEC REDWDS) grant program by the EVenergi, LLC in the amount of \$119,157; and

WHEREAS the EVenergi, LLC will administer the CEC REDWDS grants for the installation of three charging stations, develop a software charge management solutions software, and provide two-year software subscriptions at no cost to the City; and

WHEREAS, the acceptance of this grant will provide City three charging stations, software charging management solutions, and two-year software subscriptions and has no impact on City's budget; and

WHEREAS, staff recommends that the City Administrator be authorized to accept and enter into an agreement with EVenergi, LLV's for the **CEC REDWDS** grant program in the amount of one hundred nineteen thousand and one hundred fifty-seven dollar (\$119,157), for the installation of three EV chargers and software development and two-year of charging management solutions software subscriptions; now, therefore, be it

RESOLVED: That the City Council authorizes the City Administrator, or designee, to accept and enter into an agreement with Evenergi, LLV's for the CEC REDWDS grant program in the amount of one hundred nineteen thousand and one hundred fifty-seven dollars (\$119,157), for the installation of three EV chargers and software development and two-year of charging management solutions software subscriptions; and be it

FURTHER RESOLVED: That the grant does not require a matching fund or new budget appropriation; and be it

FURTHER RESOLVED: That this action is exempt from California Environmental Quality Act ("CEQA") based on the following CEQA Guidelines Sections: Section 15060(c)(2) (No Direct or Reasonably Foreseeable Indirect Physical Change in the Environment); Section 15061(b)(3) (No Significant Effect on the Environment); Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15307 (Protection of Natural Resources); Section 15308 (Protection of the Environment); and Section 15309 (Inspections), each of which provides a separate and independent basis for CEQA clearance and when viewed collectively provide an overall basis for CEQA clearance. The project as designed involves minor public or private alterations to the condition of existing facilities through the addition of electric vehicle charging stations throughout the City. The project also serves to protect the City's and region's environment and natural resources through the production and use of alternative sources of energy other than fossil fuels; and be it

FURTHER RESOLVED: That City Administrator or designee is authorized to act as an agent to conduct all negotiations and related actions and to sign all applications and agreements that may be necessary for the acceptance or extension of the CEC REDWDS grant program with EVenergi, LLC; and be it

FURTHER RESOLVED: That all contracts issued hereunder shall be reviewed and approved by the City Attorney for form and legality and copied shall be placed on file in the City Clerk's Office; and be it

FURTHER RESOLVED: That the City Administrator, or their designee or successor is, hereby authorized to take any other action consistent with this Resolution and its basic purpose.
