AN ORDINANCE AMENDING SECTION 14.8 OF ORDINANCE NO. 713 C.M.S. TO PROVIDE A \$75.00 MONTHLY INCREASE TO OAKLAND MUNICIPAL EMPLOYEES RETIREMENT SYSTEM (OMERS) RETIREES AND A \$37.50 MONTHLY INCREASE TO OMERS BENEFICIARIES

WHEREAS, the Board of Administration for the Oakland Municipal Employees' Retirement System (OMERS) requests that the City Council approve a one-time increase to the retirees and beneficiaries of the OMERS retirement plan; and

WHEREAS, the OMERS Board of Administration unanimously voted to increase monthly payments for its plan members; and

WHEREAS, said increase shall be in the amount of \$75.00 per month for retirees and \$37.50 per month for beneficiaries; now therefore

THE COUNCIL OF THE CITY OF OAKLAND DOES ORDAIN AS FOLLOWS:

Section 14.8 of Ordinance No. 713 C.M.S. is hereby amended as follows:

This benefit is to provide an increase to the monthly retirement allowance for OMERS retirees and beneficiaries. The conditions of this increase are as follows:

- (1) Every retired member's monthly retirement allowance payable by the Retirement System shall be increased by the amount of \$75.00 per month.
- (2) Every Beneficiary's monthly retirement allowance payable by the Retirement System shall be increased by the amount of \$37.50 per month.
- (3) The increase shall be paid in addition to the regular 3% Cost-of-Living Adjustment given on July 1, 2004.
- (4) The effective date of this increase is July 1, 2004.

The increase in retirement allowance provided for herein shall not be provided nor paid to the following persons:

(1) Former employees of the City of Oakland transferred to the County of Alameda effective July 1, 1957.
