

RESOLUTION AUTHORIZING THE CITY MANAGER, ON BEHALF OF THE CITY OF OAKLAND, TO NEGOTIATE AND EXECUTE A ONE-YEAR PROFESSIONAL SERVICE CONTRACT IN AN AMOUNT NOT TO EXCEED \$40,000 BETWEEN THE CITY AND PARENTAL STRESS SERVICES, INC. TO PROVIDE MENTAL HEALTH SERVICES TO THE OAKLAND HEAD START PROGRAM AND AUTHORIZING THE CITY MANAGER TO EXECUTE A ONE-YEAR EXTENSION FOR AN ADDITIONAL AMOUNT NOT TO EXCEED \$40,000

**WHEREAS**, the Head Start Program has received authorization from the U.S. Department of Health and Human Services to provide Head Start services for children in Oakland; and

WHEREAS, the Head Start Program Performance Standards promulgated by the U.S. Department of Health and Human Services for all Head Start Programs require that mental health services be made available to children and families enrolled in the Head Start Program; and

WHEREAS, the City of Oakland Department of Human Services desires to enter into a Professional Service Contract with Parental Stress Services, Inc. to provide mental health services; and

WHEREAS, the provider has met all of the requirements for mental health service providers and was among the top candidates who applied for the contract; and

**WHEREAS**, funds in the amount of \$40,000 are available to pay for these services in Fund 2128, Organization 78231, Project G223310 and Program YS01; and

WHEREAS, the City Council finds that the service is of a professional, scientific, or technical nature and is temporary in nature; now therefore be it

**RESOLVED**: That the City Council hereby authorizes the City Manager or her designee as an agent for the City to execute Professional Service Contract between the City and Parental Stress Services, Inc. in an amount not to exceed \$40,000; and, be it further

**RESOLVED**: That a copy of said contract shall be filed with the Office of the City Clerk; and, be it further

**RESOLVED**: That the City Manager or her designated representative, is hereby authorized to approve any subsequent amendments, modifications, or extensions of this Professional Service Contract, including a one-year extension of the contract for an additional amount not to exceed \$40,000, and provided that such amendments or extensions shall be approved as to form and legality by the Office of the City Attorney and filed with the Office of the City Clerk.
