

RESOLUTION No. 86115 C.M.S.

RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF NANCY SIDEBOTHAM AND EMILY D. ROGERS-PHARR AND REAPPOINTMENT OF ANGELA HALLER AS MEMBERS OF THE COMMUNITY POLICING ADVISORY BOARD

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Resolution No. 72727 C.M.S., adopted June 11, 1996 and amended by Resolution No. 73916 C.M.S., adopted November 4, 1997, which changed the body's status from a Task Force to a Board, establishes that the Community Policing Advisory Board shall oversee, monitor and report at least twice yearly and provide recommendations on community policing to the Mayor, City Council, City Manager, and director of Police Services; and

WHEREAS, the Community Policing Advisory Board consists of fifteen (15) members, all Oakland residents, serving three-year terms, three appointed by the Mayor, one by each Councilmember, one by the Oakland Housing Authority, one by the Oakland Unified School District Board, and two by the Home Alert Steering Committee; and

WHEREAS, the Honorable Mayor Libby Schaaf has appointed Nancy Sidebotham to serve a three-year term as the Home Alert Steering Committee Representative, subject to confirmation by the City Council; and

WHEREAS, the Honorable Mayor Libby Schaaf has appointed Emily D. Rogers- Pharr to serve a three-year term on the recommendation of Councilmember Rebecca Kaplan as the At-Large Representative, subject to confirmation by the City Council; and

WHEREAS, the Honorable Mayor Libby Schaaf has reappointed Angela Haller to serve a three-year term as the Home Alert Steering Committee Representative, subject to confirmation by the City Council; now therefore be it

RESOLVED: That pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of:

Nancy Sidebotham to the Community Policing Advisory Board to serve a three-year term beginning March 25, 2015 and ending March 24, 2018, filling the seat previously held by Frank Castro; and

Emily D. Rogers- Pharr to the Community Policing Advisory Board to serve a three- year term beginning March 26, 2015 and ending March 25, 2018, filling the seat previously held by Marcus Johnson; and be it

RESOLVED: That pursuant to City Charter section 601, the City Council hereby confirms the Mayor's reappointment of:

Angela Haller to the Community Policing Advisory Board to serve a three-year term beginning March 25, 2014 and ending March 24, 2017, filling the seat previously held by herself.


