Pursuant to Section 401 of the City Charter, the City Attorney has prepared and requests your approval of a resolution authorizing the City Attorney to compromise and settle the above-entitled action. Due to the risk of an adverse jury verdict under the circumstances settlement is recommended in the sum of Eighteen Thousand Dollars and No Cents (\$18,000.00) payable to Plaintiff Patricia Harper and Michael I. Dorshkind, her attorney.

This action arises from a trip and fall accident on May 16, 2009. Ms. Harper was injured when she tripped and fell in an open tree well within the sidewalk. Ms. Harper sustained injuries requiring medical treatment as a result of this accident. This matter was not heard in closed session.
