**RESOLUTION APPOINTING RYAN G. HUNTER AND JOSE A. DORADO AND AS MEMBERS OF THE VIOLENCE PREVENTION AND PUBLIC SAFETY OVERSIGHT COMMITTEE**

**WHEREAS**, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

**WHEREAS**, the Violence Prevention and Public Safety Act of 2004, also known as Measure Y, adopted by the voters of Oakland, November 2, 2004 in the General Municipal Election and amended by Ordinance No. 12690, adopted July 19, 2005, creates the Violence Prevention and Public Safety Oversight Committee to oversee and monitor the activities and procedures of the Violence Prevention and Public Safety Act; and

**WHEREAS**, the Violence Prevention and Public Safety Act of 2004 specifies that members of the Violence Prevention and Public Safety Oversight Committee are to be appointed one by each Member of the City Council and three members by the Mayor, to serve unlimited one-year terms; and

**WHEREAS**, the Honorable Mayor Jean Quan has appointed Ryan G. Hunter as District 4 Representative, as recommended by Councilmember Schaaf, and Jose A. Dorado as Mayoral Representative to seats on the Committee, each to serve one year terms subject to confirmation by the City Council; now therefore, be it

**RESOLVED**, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Ryan G. Hunter and Jose A. Dorado to the Violence Prevention and Public Safety Oversight Committee for one-year terms, Hunter beginning April 19, 2011 and ending April 18, 2012, filling the seat previously

held by Jose A. Dorado, and Dorado beginning June 7, 2011 and ending June 6, 2012 filling the seat previously held by Brandon Sturdivant.


