Dear Councilmember Kernighan,

My name is Tyson Nagler and I am interested in participating on the Oakland Cannabis Regulatory Commission. I understand there is a vacancy for a committee member to be nominated by you, as Oakland City Councilmember from District 2. I have the background and ability to help oversee the ordinance's implementation and the disbursement of revenue from licensing and taxation of businesses that sell cannabis. I believe this is a unique opportunity for the City of Oakland to be at the forefront of changes in the regulation and legal status of cannabis in our state and country, and to develop strong, yet reasonable ordinances that secure and support our community. I, too, wish Oakland to be a safe and enjoyable place to raise a family, work, and operate a business. Please allow me to tell you briefly about my knowledge and experience.

I have been an Oakland resident since 2005 and own a house with my wife, Molly, in District 6 where we reside with our two children, Mariel and Henry, almost 5 and 3 years old respectively. Since 2005 I have been working at UC Berkeley, but was iaid-off earlier this year after a merger of procurement operations took place with UC San Francisco and my position became redundant. For now, i am a stay-at-home dad, but for the past 3 years I was the finance and budget officer for Procurement Services and the procurement card administrator for campus. As well, I was the co-Lead for Procurement on the BearBuy project team during its multi-year implementation under the auspices of UC Berkeley's "Operational Excellence" initiatives.

I had originally joined the Haas School of Business at UC Berkeley as its Business Manager in 2005. I worked closely with faculty, staff, and central campus to identify our business needs, re-engineer internal processes for efficiency, streamline outdated procedures for effectiveness, clearly communicate department practices, and manage change. As well, I researched policy concerns and established department interpretations, ensured appropriate financial controls were in place and monitored for inconsistencies, and managed the fiscal close.

During the last 8 years, I also took time to help build and strengthen the community on campus. In particular, I joined the Berkeley Staff Assembly (BSA) in 2008 and served as Chair of the Governing Council for 2011-12. During my tenure as Chair, staff membership in the Assembly rose to more than 7,000 after we successfully amended our Bylaws and Operating Procedures to become more inclusive and inviting. I was also nominated by the Vice Chancellor of Administration and Finance to serve as the staff representative on the UC Berkeley Police Review Board (PRB). The PRB's primary responsibility during that time was to review a major incident that happened November 9, 2011 on campus involving police and protesters. We were directed to report on and make policy improvement recommendations to the Chancellor, which we successfully completed.

Please find my resume enclosed. I believe my experience in collaborating with others to work toward a common goal, ensuring all voices are heard, and building consensus, in addition to my finance and accounting background, would be useful to this commission. I would be happy to meet or talk with you about this vacancy at your convenience. Thank you for your time and consideration.



INTRODUCED BY MAYOR JEAN QUAN		

RESOLUTION APPOINTING TYSON NAGLER AS A MEMBER OF THE CANNABIS REGULATORY COMMISSION

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, the Oakland Cannabis Regulation and Revenue Act (Ordinance 12694 C.M.S.), also known as Measure Z, adopted by the voters of Oakland, November 2, 2004 in the General Municipal Election, creates the Cannabis Regulatory Commission to oversee the ordinance's implementation and the disbursement of revenue from licensing and taxation of businesses that sell cannabis; and

WHEREAS, the Oakland Cannabis Regulation and Revenue Act specifies that members of the Cannabis Regulatory Commission are to be appointed one by the Mayor, one by the City Auditor, one by the City Administrator, and one from each Member of the City Council, to serve unlimited two-year terms; and

WHEREAS, the Honorable Mayor Jean Quan has appointed Tyson Nagler as the District 2 Representative, as recommended by Council President Pat Kernighan, to sit on the Committee, to serve a two-year term subject to confirmation by the City Council; now therefore, be it

RESOLVED, that pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment of Sierra Martinez to the Cannabis Regulatory Commission to finish out the two-year term that was previously vacated by Charlie Mintz, beginning August 1, 2012 and ending July 31, 2014.

FURTHER RESOLVED, that Tyson Magier term of office on the Cannabis Regulatory Commission shall begin on the first day after the City Council approves this resolution.
