INTRODUCED BY COUNCILMEMBER DAN KALB

RESOLUTION IN SUPPORT OF AB 922 (WICKS) TO ESTABLISH THE PREPARED MEALS DELIVERY PROGRAM UNDER THE STATE DEPARTMENT OF SOCIAL SERVICES FOR THE PURPOSE OF PROVIDING MEALS TO UNHOUSED INDIVIDUALS AND REQUIRING THE COUNTY OF ALAMEDA TO PARTICIPATE IN THE PROGRAM

WHEREAS, in September 2023 Alameda County Supervisors declared a State of Emergency on homelessness after the 2022 Point in Time Count showed its unhoused population jumped 22% since 2019; and

WHEREAS, Oakland's population represents 26% of Alameda County, but 52% of the homeless population; and

WHEREAS, without a mailing address, reliable phone service or documentation required for enrollment, our homeless community has difficulties accessing public benefits programs like CalFresh; and

WHEREAS, once enrolled in public benefits programs like CalFresh, some homeless community members must walk 3-5 hours to access retail stores to use their EBT card; and

WHEREAS, because homeless individuals do not have kitchens, there are limited healthy options using EBT cards; and

WHEREAS, from October 2020 through December 2021, Alameda County's Emergency Food Vendor program distributed 5 million prepared meals using one-time CARES Act and ARPA Funds, there is currently no ongoing funding for these meal programs; and

WHEREAS, during the pandemic lockdown the City of Oakland's partnership with restaurants to provide meals for both homeless residents provided essential nourishment and proof of successful service delivery that should be a standard going forward; and

WHEREAS, policy research shows that governments can end hunger when they use multiple avenues to connect people to food, including restaurants; and

WHEREAS, pandemic meal deliveries had a significant impact on our local restaurants, helping them survive the pandemic, and AB 922 provides meaningful and appropriate opportunities for them to participate in programs to serve the broader community; and

WHEREAS, this bill would require the State Department of Social Services to establish the Prepared Meals Delivery Program for the purpose of providing meals to unhoused individuals, in order to contribute to lasting food security and a path to stable, permanent housing; and

WHEREAS, the bill would require the County of Alameda to participate in the program and to select a community-based organization as a grantee of funding for the program based on a bidding process, as specified; and

WHEREAS, the bill would require the delivery of food directly to unhoused encampments, as specified, with an average cost of \$14.50 per meal per day; and

WHEREAS, the bill would require the County of Alameda to submit periodic reports of performance data to the department while implementing the program, requiring a report to the legislature, no later than June 1, 2026, evaluating the effectiveness of the program; and

WHEREAS, the bill would appropriate \$6,000,000 from the General Fund to the department, for allocation to the County of Alameda over 3 years, for the purpose of implementing the program; and

WHEREAS, AB 922 is a model for localizing and equitably distributing the resources we need to care for each other, increasing food access and helping local businesses, as well as enshrining a system of mutual aid and support; now, therefore, be it

RESOLVED: That the Oakland City Council supports the passage of AB 922 (Wicks); and be it

FURTHER RESOLVED: That the City Council directs the City Administrator or his designee to immediately distribute this Resolution upon its adoption to Governor Gavin Newsom and State Assembly member Wicks.
