Is there a statutory, regulatory, financial or grant deadline? Yes. Specify: Oakland's final grant application will be due to the Alameda County Congestion Management Agency in early August.

What is the fiscal impact on the City/Agency? Oakland will benefit by receiving \$572,800 of additional federal funds for maintenance of local streets and roads by "buying" all federal rehab funds available to Alameda County in FY 05-06 and 06-07 at 90 cents on the dollar. Oakland will also receive \$1.416 million of local transportation funds as its share of the proceeds from the exchange of local transportation funds for the County's federal rehab funds. The total net gain for Oakland will be \$1.989 million of new funds for transportation rehab projects in FY 05-06 and 06-07.
