



RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO AWARD A CONTRACT TO MARK RITE LINES EQUIPMENT CO., INC, THE LOWEST RESPONSIBLE, RESPONSIVE BIDDER, A CORPORATION, TO PROVIDE TWO (2) 2015 MODEL TRAILER MOUNTED THERMOPLASTIC PRE-MELTING KETTLES, IN AN AMOUNT NOT TO EXCEED ONE HUNDRED SIX THOUSAND SEVEN HUNDRED FORTY-NINE DOLLARS AND FIFTY-FIVE CENTS (\$106,749.55) PER REQUEST FOR QUOTATION (RFQ) NO. 5485, SPECIFICATION NO. 15-070-59 AND THE GENERAL CONDITIONS THEREFOR ON FILE IN THE PURCHASING SECTION ACCORDING TO ITS BID FILED WITH THE CITY ON APRIL 20, 2015.

WHEREAS, on March 26, 2015, the City issued and advertised Specification No. 15-070-59/RFQ No. 5485 to provide two (2) 2015 model trailer mounted thermoplastic pre-melting kettles; and

WHEREAS, on April 20 2015, the City Clerk received and opened two bids in response to Specification No. 15-070-59/RFQ No. 5485 to provide two (2) 2015 model trailer mounted thermoplastic pre-melting kettles; and

WHEREAS, the bids submitted by Mark Rite Lines Equipment, the lowest responsible, responsive bidder, a corporation, was deemed by the evaluation committee to be the lowest responder to Specification No. 15-070-59/RFQ No. 5485; and

WHEREAS, funds are available in the State Gas Tax Fund (2230), Electrical Services Traffic Maintenance Organization (30523), Furniture and Equipment Account (57511), Undetermined Project (0000000), Traffic Signs and Markings Management (NB40) and; now be it

RESOLVED: That the City Council authorizes the City Administrator to enter into a contract to purchase two (2) 2015 model trailer mounted thermoplastic pre-melting kettles to Mark Rite Lines Equipment, the lowest responsible, responsive bidder, in an amount not to exceed one hundred six thousand seven hundred forty- nine dollars and fifty-five cents (\$106,749.55) in accordance with Specification No. 15-070-59/RFQ No. 5485 and the general conditions therefor on file with Purchasing according to its bids submitted on April 20, 2015; and be it

FURTHER RESOLVED, That the City Council hereby rejects all other bids submitted in response to RFQ No. 5485; and be it

FURTHER RESOLVED, That the contract shall be approved for form and legality by the City Attorney and copies shall be on file in the City Clerk's Office.


