SUMMARY

At its meeting of May 11, 2010, the Finance and Management Committee of the City Council requested additional information regarding the business ownership, location, Local/Small Local Business Enterprise (L/SLBE) certification, and business tax certification for the proposed As-Needed Real Estate Appraisal Services contractors.

Below is a table supplementing Table 1 from the original staff report with the additional information requested by the Committee.

Of the four Oakland-based businesses, two are certified Oakland Small Local Business Enterprises. One of the main reasons staff has identified these two contractors as Tier III, \$100,000 contractors, is because of their SLBE certification status. Staff from the City's

Department of Contracting and Purchasing (DCP) will contact both non-certified businesses to encourage certification as a local Oakland firm. Additionally, as part of advertising and issuing the Appraisal Services RFP, DCP staff developed a list of certified Oakland appraisal firms, and each of these firms was mailed an Appraisal Services RFP. There are a limited number of state of California licensed general Real Estate appraisers located in Oakland that have experience performing public agency and eminent domain related appraisals that meet federal, State and local acquisition appraisal requirements.

Finally, of the eleven firms, seven firms are minority and/or women-owned. All firms that the City hires to perform services are required to pay business taxes. Such firms are required to obtain a Business Tax Certificate from the City's Business Tax Section, report annual income, and pay taxes on the income reported. Of the eleven firms, eight have Business Tax Certificates. The three remaining must obtain a valid Oakland Business Tax Certificate in order to obtain certification, although the tax certificate and payment of business taxes is required regardless of whether a firm qualifies for "local" business certification.
