**RESOLUTION RE-APPOINTING COUNCILMEMBER NOEL GALLO TO THE JOINT POWERS AUTHORITY BOARD OF DIRECTORS OF THE ALAMEDA COUNTY LEAD POISONING PREVENTION PROGRAM AND REAPPOINTING DIRECTOR WILLIAM GILCHRIST AS THE OFFICIAL ALTERNATE FOR COUNCILMEMBER GALLO FOR TERMS COMMENCING JANUARY 1, 2025, AND ENDING DECEMBER 31, 2026**

**WHEREAS**, the City of Oakland has some of the highest rates of childhood lead exposure in the state of California; and

**WHEREAS**, in 1992, the Cities of Oakland, Berkeley, and Alameda, entered into a Joint Powers Agreement, forming the Alameda County Lead Poisoning Prevention Program; and

**WHEREAS**, the program is governed by a Joint Powers Authority (JPA) Board of Directors comprised of a representative of the City Council of each participating city, the Alameda County Board of Supervisors, and a Community Representative; and

**WHEREAS**, Rule 6 of the Council's Rules of Procedure provides that, except for appointments reserved to the Mayor under the City Charter, the Council President shall recommend appointments to regional and local boards and agencies as appropriate subject to confirmation of the City Council; and

**WHEREAS**, Councilmember Noel Gallo was appointed in 2023 as Oakland's representative on the Joint Powers Authority Board of Directors of the Alameda County Lead Poisoning Prevention Program for a term commencing January 1, 2023, and ending December 31, 2024; and

**WHEREAS**, Director of the Department of Building and Planning William Gilchrist was appointed to serve as the official alternate for Councilmember Noel Gallo for a term commencing January 1, 2023, and ending December 31, 2024; now therefore be it

**RESOLVED:** That Councilmember Noel Gallo is hereby reappointed to the serve as Oakland's representative on the Joint Powers Authority Board of Directors of the Alameda

County Lead Poisoning Prevention Program for a term commencing January 1, 2025, and ending December 31, 2026; and be it

**FURTHER RESOLVED:** That Director William Gilchrist is hereby reappointed to serve as the official alternate for Councilmember Noel Gallo for the term commencing January 1, 2025, and ending December 31, 2026.


