RESOLUTION OVERRULING PROTESTS AND OBJECTIONS AND ACCEPTING AND CONFIRMING REPORTS OF THE CITY ADMINISTRATOR FOR DELINQUENT TRASH SERVICE FEES WITH ADMINISTRATIVE AND SPECIAL ASSESSMENT CHARGES AS NECESSARY PURSUANT TO CHAPTER 8.28 OF THE OAKLAND MUNICIPAL CODE, AND DIRECTING THE NOTICE OF SPECIAL ASSESSMENT CHARGES BE TURNED OVER TO THE COUNTY TAX COLLECTOR FOR COLLECTION FOR THE MONTHLY PERIODS OF APRIL, MAY, JUNE 2021, JANUARY, FEBRUARY, MARCH 2022, QUARTERLY PERIODS OF JULY-SEPTEMBER 2021, AND APRIL-JUNE 2022

WHEREAS, pursuant to Chapter 8.28 of the Oakland Municipal Code (“OMC”), the City Administrator’s Report accompanying this resolution, and incorporated herein by reference, includes a list of those properties subject to special assessment for delinquent trash service fees with added administrative and special assessment charges; and

WHEREAS, the date June 21, 2022 and the time 1:30 p.m., was fixed as the day and hour of the public hearing for the Council to hear and consider the reports concerning delinquent trash service fees with added administrative and special assessment charges, and any protests or objections to said reports, and at the public hearing the City Council continued the hearing to the July 19, 2022 Council meeting; and

WHEREAS, pursuant to OMC Chapter 8.28 notice was served upon the owners of the premises to which the service was rendered not less than ten days prior to the date of the hearing; now, therefore, be it

RESOLVED: That the protests are hereby overruled; and be it

FURTHER RESOLVED: That the City Administrator’s Report accompanying this resolution concerning delinquent trash service fees with administrative and special assessment charges for the real property described therein is hereby accepted and confirmed, and the special assessments are hereby authorized to be levied upon the properties described in said City Administrator’s Report in the amounts set opposite each description for costs incurred for delinquent trash service fees, with added administrative and special assessment charges; and be it

FURTHER RESOLVED: That if any special assessment levied on a property is not paid before the 10th day of August 2022, the City Administrator shall present an itemized report to the Auditor-Controller of the County of Alameda, State of California, to be placed on the 2022-2023 County Tax Roll.
