Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends adoption of a resolution authorizing settlement of the above-entitled matter arising from an incident on January 24, 2003, in which an OPD officer injured plaintiff while plaintiff was being arrested in the 2400 block of 25th Avenue, Oakland. This matter was approved by the Council at the May 18, 2004 closed session.

Due to the risk of an adverse jury verdict under the circumstances, settlement is recommended in the amount of Nine Thousand Five Hundred Dollars and No Cents (\$9,500), to be made payable to Lolinh Saelee and Diana T. Frappier Esq., his attorney.
