**ORDINANCE AMENDING THE SALARY SCHEDULE OF ORDINANCE NO. 12187 C.M.S. ("SALARY ORDINANCE") TO ADD THE FULL-TIME CLASSIFICATION OF MANAGER, TRANSPORTATION; TO ADD THE FULL-TIME CLASSIFICATION OF ACCOUNTING ANALYST, PRINCIPAL; TO ADD THE FULL-TIME CLASSIFICATION OF BUYER, SENIOR; TO ADD THE FULL-TIME CLASSIFICATION OF COURIER; TO AMEND THE TITLE OF THE FULL-TIME CLASSIFICATION OF REPRODUCTION OFFSET OPERATOR TO REPROGRAPHIC OFFSET OPERATOR; AND TO AMEND THE TITLE OF THE FULL-TIME CLASSIFICATION OF REPRODUCTION ASSISTANT TO REPROGRAPHIC ASSISTANT.**

This ordinance authorizes changes to the City's Classification Plan as shown in the City's Salary Schedule to add new classifications and amend existing classification titles. Various departments are requesting new classifications to align with operational and service delivery needs; this applies to the new Transportation Manager, Principal Accounting Analyst, Senior Buyer, and Courier classifications. The job titles of the reprographic shop classifications are being revised to modernize them by replacing an outdated reference to reproduction.
