RESOLUTION RATIFYING ACTION TAKEN BY THE MAYOR DURING THE OAKLAND CITY COUNCIL 2004 ANNUAL RECESS IN CONFORMANCE

WITH RESOLUTION NO. 78307 C.M.S. DATED JANUARY 20, 2004

SUMMARY

The City Council's Annual Recess began August 3, 2004, and ended September 7, 2004. During the Annual Recess the Mayor was authorized to take such actions as would normally be taken by the City Council during the period of the Annual Recess except for duties reserved to the City Council by the City Charter, pursuant to Resolution No. 78307 C.M.S., dated January 20, 2004.

The City Council granted authorizations to the Mayor to take action on procurement of certain supplies and services exceeding \$500,000 and certain professional services contracts exceeding \$150,000 during the 2004 Annual Recess, pursuant to Resolution No. 78307 C.M.S., dated January 20, 2004.

RESOLUTION RATIFYING ACTION TAKEN BY THE MAYOR DURING THE OAKLAND CITY COUNCIL 2004 ANNUAL RECESS IN CONFORMANCE WITH RESOLUTION NO. 78307 C.M.S., DATED JANUARY 20, 2004

WHEREAS, the City Council has taken its Annual Recess August 3, 2004, and ending September 7, 2004, pursuant to Resolution No. 78307 C.M.S., dated January 20, 2004 and

WHEREAS, pursuant to City Council Resolution No. 78307 C.M.S., passed January 20, 2004 delegating certain authority to the Mayor during the Annual Recess of the City Council, the following actions were taken:
