**RESOLUTION AWARDING A PROFESSIONAL SERVICES AGREEMENT TO WOOD RODGERS FOR ENGINEERING SERVICES FOR THE CITY OF OAKLAND'S STORM DRAINAGE MASTER PLAN PROJECT NO. 1005274 IN AN AMOUNT NOT TO EXCEED THREE MILLION THREE HUNDRED NINETY-ONE THOUSAND DOLLARS (\$3,391,000.00).**

**WHEREAS**, the City of Oakland (City) is in need of a comprehensive Storm Drainage Master Plan (SDMP) to provide technical guidance for how to best manage, improve, and extend the life of the City's 400 miles of storm drainage pipes, 80 miles of creeks and waterways, 18,000 drainage structures, 11 pump stations, and other drainage appurtenances; and

**WHEREAS**, the SDMP will include an inventory and condition assessment of the City's storm drainage facilities, a recommended capital improvement program for the storm drainage system to prevent flooding, erosion, and water quality impacts, a maintenance and operation plan to support the longevity of the City's storm drain assets, and identification of opportunities for system improvement through projects that achieve multiple benefits including meeting water quality goals and regulations and helping the City achieve climate change resiliency and equity goals; and

**WHEREAS**, each capital improvement project (CIP) recommended by the SDMP will be prioritized using the City's CIP ranking process which utilizes equity as a key prioritization factor; and

**WHEREAS**, on June 12, 2020, the City issued a Request for Proposals (RFP) for engineering services for Storm Drainage Master Plan and received two (2) proposals; and

**WHEREAS**, the two (2) proposals were evaluated by a panel of three (3) professionals with experience in the scope of services identified in the RFP; and

**WHEREAS**, based on the panel's evaluation and contract requirements, Wood Rodgers was recommended as the most qualified consultant to perform the services; and

**WHEREAS**, the City Administrator has determined that this contract is for services of a professional, scientific, or technical and temporary nature; and

**WHEREAS**, the City Administrator has determined that this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

**RESOLVED:** That the City Administrator or designee is hereby authorized to enter into agreement with Wood Rodgers to provide professional Engineering Services for Oakland's Storm Drainage Master Plan Project No. 1005274 in an amount not-to-exceed Three Million Three Hundred Ninety-One Thousand Dollars (\$3,391,000.00); and be it

**FURTHER RESOLVED:** That the City Administrator or designee is hereby authorized to approve any subsequent amendments to or extensions of said agreement, provided that such amendments or extensions shall be approved for form and legality by the City Attorney and a copy shall be kept on file with the City Clerk.


