

Dear President De La Fuente and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends settlement of the above-entitled matter arising from an incident on September 9, 2002, in which plaintiff tripped and fell over a broken City sidewalk.

Due to the risk of an adverse jury verdict under the circumstances, settlement is recommended in the amount of Eighteen Thousand Dollars and No Cents (\$18,000.00), to be made payable to Janet Greene and Steven J.
