## **RECOMMENDATION**

Staff Recommends That The City Council Adopt A Resolution Authorizing The City Administrator To Award A Contract To Moeller Bros. Body Shop, The Lowest Responsive And Responsible Bidder, A Non-Local Business Enterprise, In An Amount Not-To-Exceed One Million Dollars (\$1,000,000) Per Year To Provide Collision Repair And Body Shop Services For Heavy And Light Equipment Vehicle Fleet For An Initial Three (3) Year Term, From February 20, 2024 To February 19, 2027, With Two (2) Additional One (1) Year Options To Extend The Term Of The Agreement, For An Initial Contract Total Amount Of One Million Dollars (\$1,000,000) Per Year, For A Grand Total Not-To-Exceed Contract Amount Of Five Million Dollars (\$5,000,000) For A Potential Total Contract Term Of Five (5) Years, Provided That The City Administrator Will Return To Council Prior To The Expiration Of The Initial Three Years Of The Contract And Before Exercising The First or Second Options to Extend The Contract, And Waiving The Local And Small Local Business Enterprise Program Requirements.

## **REASON FOR SUPPLEMENTAL**

At its meeting on February 13, 2024, during discussion of staff's recommendation to award a contract to Moeller Bros. Body shop for collision repair services, the Public Works and Transportation Committee (PWTC) directed staff to provide additional information regarding outreach performed by the City to potential applicants located in Oakland, as well as the names of the Oakland businesses that applied. The requested information is detailed in this supplemental report.

The Finance Department, Purchasing Division, created two Requests for Proposals (RFPs). RFP #271233 was created for heavy equipment collision repairs and body shop services, and RFP #271237 was created for light equipment collision repairs and body shop services. Both RFPs were shared with all eligible vendors registered in the City's isupplier system (Table 1), or sent directly to vendors upon request.

Additionally, the Oakland Public Works, Equipment Services Division contacted the following four (4) small local businesses to notify them of the upcoming opportunity to conduct business with the City - Uptown Body and Fender, Hustead's Auto Body, Automotive Collision Repair, and Fast Collision Center Auto Repair. Out of these four (4) local businesses, three (3) registered with the City of Oakland as potential vendors, however none submitted a bid for RFP #271233 or RFP #271237.

Staff Recommends That The City Council Adopt A Resolution Authorizing The City Administrator To Award A Contract To Moeller Bros.
