The Children's Initiative Commission has been fully vacant and requires immediate attention to resume its important work supporting our community's youngest residents. This commission plays a vital role in advising the city on policies and programs that impact children and families.

### **Proposed Actions:**

- Authorize the appointment of qualified community members to fill all vacant positions
- Establish staggered terms to ensure continuity of service going forward
- Hold the commission's first meeting within 30 days of appointments

**Next Steps:** The Mayor's Office will present candidate recommendations at the next Council meeting. All proposed appointees meet the qualifications outlined in the municipal code and represent diverse community perspectives.

Restoring this commission will enable the city to move forward with pending children's programs and policy reviews that have been delayed due to the vacancy.

We appreciate the Council's prompt consideration of these appointments.

I was elected to serve on the Oakland Board of Education representing District 1 from 2020-2024 and have a deep relationship with our school district, having also taught in OUSD for 8 years and my child attended K-12, graduating from Oakland Tech in 2024. Violence prevention begins in our high schools since getting young people on the right track is essential to community health and safety. I also served on the board of Oakland Community Organizations, later Faith in Action East Bay, from 2012-2019, where I developed a great appreciation for the Ceasefire strategy and how it drastically reduced homicides in Oakland over that period. Finally, as a member of Kehilla Community Synagogue, I have advocated forcefully for immigrant rights and for sanctuary policies in Oakland and the East Bay, as well as the ACILEP hotline. Our most successful campaign was to close the ICE detention center at the West County Detention Center in Richmond in 2019. For my application to serve on the Children's Initiative Oversight Commission, I would fulfill the categories of: professional experience in TK-12 education, experience in budgeting, Oakland homeowner, and professional experience in support for traditionally underrepresented college students. With respect to the last category, I led the successful campaign to renew the College and Career For All initiative in OUSD, which passed on the November 2022 ballot with over 80% yes votes, and I have worked for 11 years on the UC Compass project with the UC Office of the President, which provides school districts across the state with data to increase college access for underrepresented communities.

In 2016, I assumed the executive leadership of BANANAS and have been deeply involved in the early care and education (ECE) ecosystem that supports our youngest learners in Oakland. In my role, I have had the privilege of working with and supporting early learning educators as they work tirelessly to instill the love of learning in young children, despite the lack of resources and inadequate compensation. The pandemic amplified the need for reform and better support for early educators, which includes better compensation, benefits and professional development. In my role, I see how early care and education influences the trajectory of a family's life. Without quality, reliable and affordable child care, parents cannot work, thus threatening their economic stability. ECE provides children with enriching experiences in these early years when their brain development is most active. Parents and educators have reported their observation of developmental delays in many children in the last two years. It lays bare the importance of education in the early years and how an interruption like we have experienced impacts development in the young brain. I sit on several ECE policy and advocacy tables where pedagogies and strategies have been piloted and proven to ensure good outcomes for our students, especially those furthest from opportunity. Funding is needed to scale these initiatives. Oakland learners - from our youngest to those at the cusp of adulthood - deserve more. I am excited and encouraged about the revenue stream Measure AA funds will do for Oakland students. My love of early education was sparked decades earlier by my mother who taught elementary school for 35 years. I witnessed how a dedicated educator could inspire any student to increase their confidence, enhance their skills and thrive. In the years since, I have observed how the level of investment in schools and education experiences has an impact on its students and families. If appointed to this oversight commission, I will leverage and weave my lived and observed experiences and skills to ensure this funding stream is being used as promised to the voters. As Chair of the Alameda Early Care and Education Planning Council, I work in collaboration with its members to amplify the priorities and needs of our children, recommend strategies, educate policymakers and advocate for resources and legislation. The Planning Council has representation from Alameda County systems, LEAs, CBOs, educators and parents. I will bring this lens to the oversight committee. At Oakland Starting Smart and Strong, we have piloted successful strategies to enhance the experiences of our ECE teachers and their students. These initiatives are candidates for scaling with Measure AA support. My personal experiences as an Oakland Promise mentor will provide a perspective of how we can support our young adults as they embark upon higher educational pursuits. The BANANAS CARE program supports unhoused families with young children and has highlighted to me the need for resources to support the children, families, and the educators that teach and interact with them so students can reach their full potential. I have a very diverse background and set of experiences that will inform my thought process and collaboration with fellow commissioners. I am grateful for the opportunity to support our youngest to those on the threshold of adulthood so they can reach their full potential and make Oakland a wonderful place for all types of families. As a homeowner in District 4 for 30 years and parent of an adult daughter who wants Oakland to be her home and to raise a family here, this is a very important responsibility. I am the Founder and now Director Emerita of the Center for the Study of Child Care Employment at UC Berkeley, Since 1999, the Center for the Study of Child Care Employment (CSCCE) has been uniquely focused on the people who care for and educate young children and its goals are aligned with the mission of the Children's Commission to ensure that the parcel tax resources will expand high quality child care and preschool serving lowest income families in Oakland as well as increase access to education for children's educators. My roots go back 50 years to the previous generations of child care teachers working on these issues. I began my career as an infant/toddler and preschool teacher in Berkeley and Oakland, then joined with educators to establish the Child Care Employee Project (CCEP). CCEP coordinated the then emerging teacher-led movement dedicated to securing rights, raises, and respect for educators and the necessary public financing to improve child care jobs and services for families and participated in a teacher-led compensation movement that culminated in the grassroots nationwide Worthy Wage Campaign of the 1990s rooted in Oakland where I have resided since 1977. I am internationally known for groundbreaking early education workforce research and policy proposals to ensure dignity for educators, children, and families participating in the ECE system and increase and support opportunities for educators to pursue higher education. Prior to founding CSCCE in 1999 and leading the organization for two decades, I earned a master's degree in Early Childhood Education from UC Berkeley and a Ph.D. in Developmental Studies from the UCLA Graduate School of Education. I am a parent and grandparent and currently provide child care for my 3 year old granddaughter in my home to augment her center-based child care experience. Since 1999, the Center for the Study of Child Care Employment (CSCCE) has been uniquely focused on the people who care for and educate young children. We document their experiences, needs, and the multiple ways in which the current early care and education (ECE) system fails them. We call out the policies that undermine the economic security and well-being of the ECE workforce and identify how they can be improved. CSCCE has built on the teacher-centered tradition of research and policy that CCEP began, leading to the landmark 2014 publication Worthy Work, STILL Unlivable Wages, which in turn laid the groundwork for the biennial Early Childhood Workforce Index and Racial Wage Gaps in Early Education Employment available at CSCCE. During the first year of the COVID-19 epidemic, when early educators were expected to work as K-12 schools closed, the CSCCE was one of the few organizations to speak out on the need to treat child care as essential and protect their health and livelihoods. As Director Emerita of the Center for the Study of Child Care Employment at UC Berkeley, I lead ECHOES (Early Childhood History, Organizing, Ethos and Strategy) project connecting early care and education today with its history and activism for a more equitable system. 



I am the Principal of the Pregnant and Parenting School for Alameda County. Before that, my entire career has been in OUSD. I started the first continuation school for newcomers in the country, Rudsdale Newcomer, and that started my experience with this very high needs population. During my tenure there, many young moms tried to come to our school but could never manage the demands of work, school and parenting. As a mother of 3 myself, I was always heartbroken when they would drop out and frustrated at how difficult it was for these students to get connected to support. After the shooting at Rudsdale, I started working on a special project--supporting the list of 90+ Newcomers who had dropped out due to being pregnant or actively parenting. During 6 months, I became an expert in all things daycare in Oakland, I worked closely with Bananas and got 25 girls into the FFN program. I worked closely with OUSD ECEs and got a number of children into those programs. I also figured out many of the problems--East Oakland does not have enough Spanish speaking daycares! And our Mayan Guatemalan students really don't have any options of Native language centers. Not to mention the many deterrents to applying and getting placed especially for our young moms who are not fluent or even worse, undocumented. That is when I was hired to run Hobbs Academy so that it could finally serve our immigrant youth. I grew the program from 3 students all the way to 19 and we are still getting referrals. I'm also still working with Rudsdale and OUSD to complete my dream of opening daycare centers there for any OUSD students. All this is to say that not only do I know a lot about the Early childhood needs here in Oakland, but I am connected to a ton of youth who are pregnant or parenting, both currently with me at Hobbs and those that were too old to join us or who I worked with in the past. I would love to be on this commission to help identify they needs and support this money being used to get our youngest mothers the supports they need so that both them and their families can thrive!
